Words and phrases to know in 2026

Debasement trade

The broad diversification away from fiat currencies such as the dollar and towards gold, bitcoin, etc.

Digital native

A person born or brought up during the age of digital technology and therefore familiar with computers and the internet from an early age.

Fear of a better option (FOBO)

The anxiety that something better will come along, which makes it undesirable to commit to existing choices when making a decision. This specifically refers to decisions where there are perfectly acceptable options in front of us, yet we struggle to choose just one. An affliction of abundance.

Generative engine optimization (GEO)

A digital marketing strategy that focuses on optimizing content to be used as a source by AI-powered search engines like ChatGPT, moving beyond traditional SEO methods.

Ghost jobs

Job listings for positions that do not exist or that employers have no intention of filling immediately; often used to project an image of growth, drive traffic to websites, or build a resume database.

Job hugging

The act of staying in your current job, even if not satisfied, due to an uncertain labor market. Opposite of “job hopping,” which gained popularity during the “Great Resignation” of 2021 and 2022.

Paper ceiling

An invisible barrier limiting the career advancement of workers without a bachelor’s degree.

Skilled through alternative routes (STARs)

Adults who have developed marketable skills through methods other than a traditional four-year bachelor’s degree, such as on-the-job experience, military service, community college, or vocational training programs.

Upstander

Someone who risks their own social capital to stand up against injustice.

Working grandma

A grandmother who remains in the workforce, often balancing her career with providing childcare and support for her grandchildren.

Zillennials

A micro-generation born on the cusp of the Millennial and Gen Z generations, typically from the early to mid-1990s to the late 1990s or early 2000s.

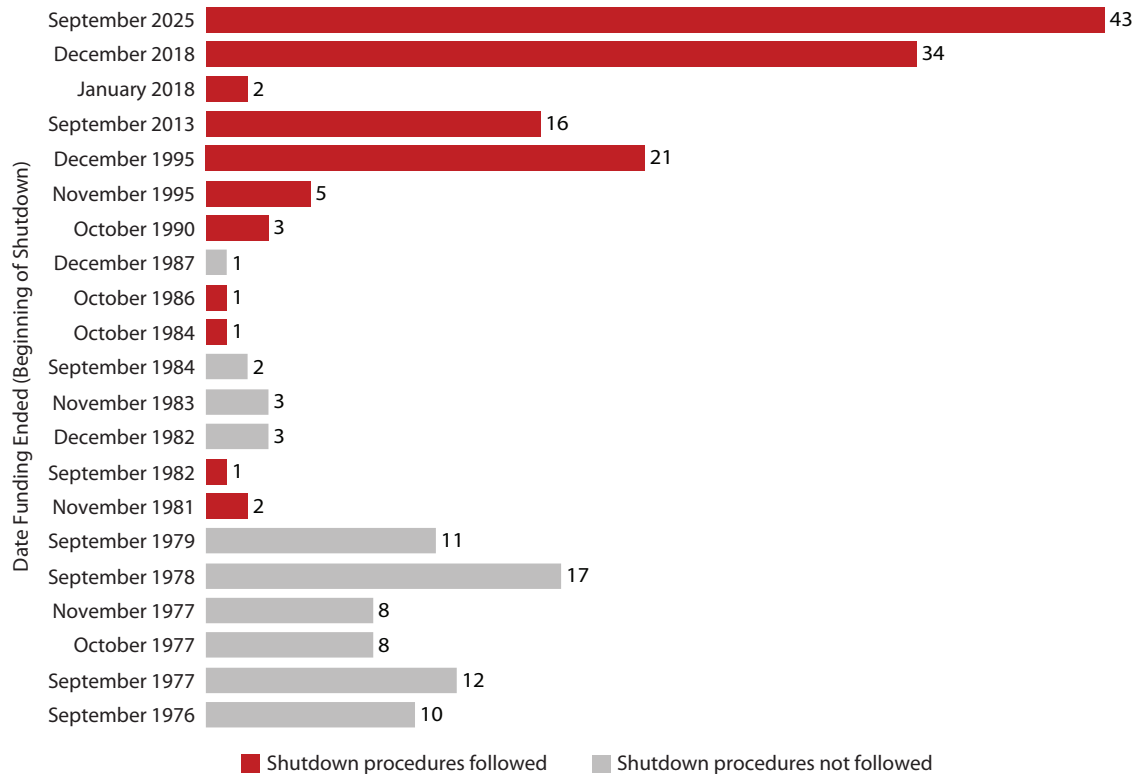
Presidential Executive Orders in First 100 Days

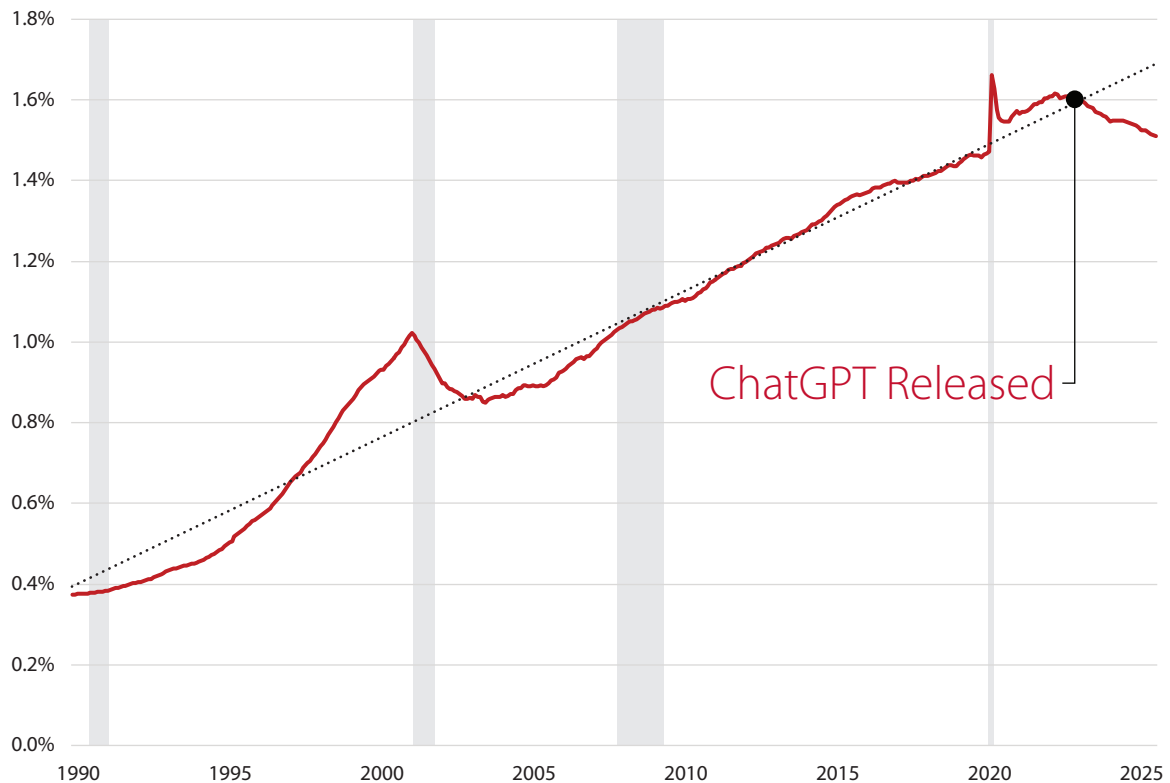
Duration of Funding Gaps in U.S. Federal Government Shutdowns, 1976-2025

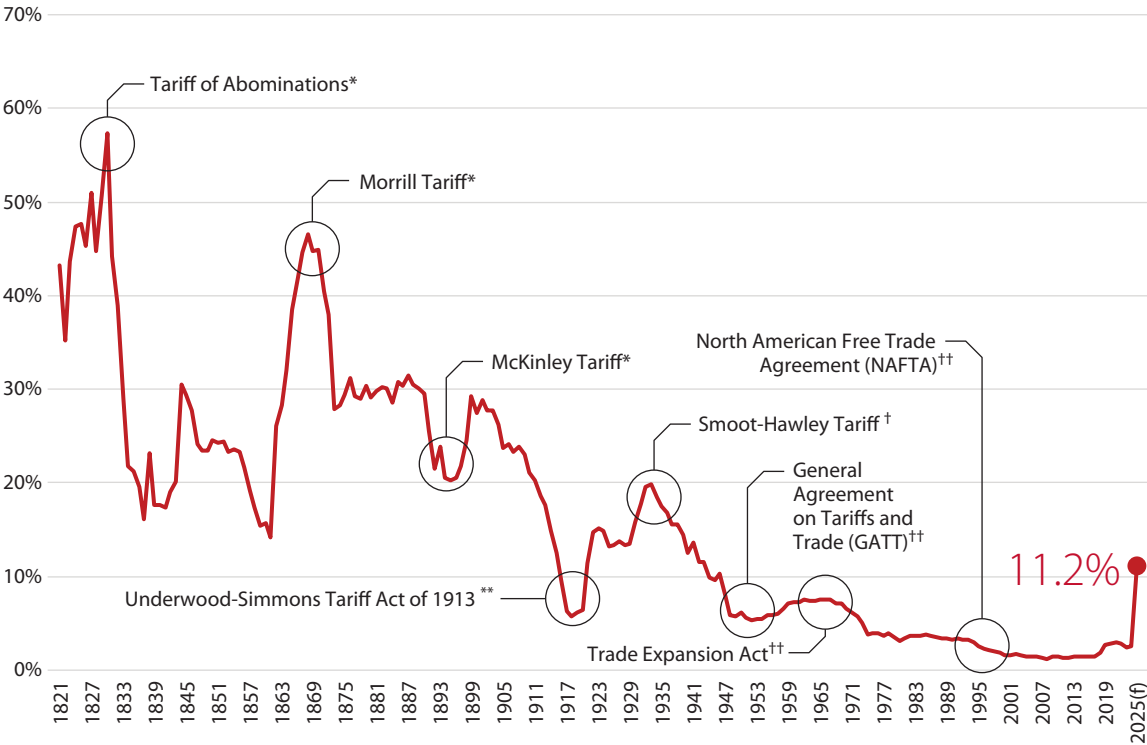
U.S. Tech Services Jobs as Share of Total Nonfarm Employment, Jan 1990-Sept 2025

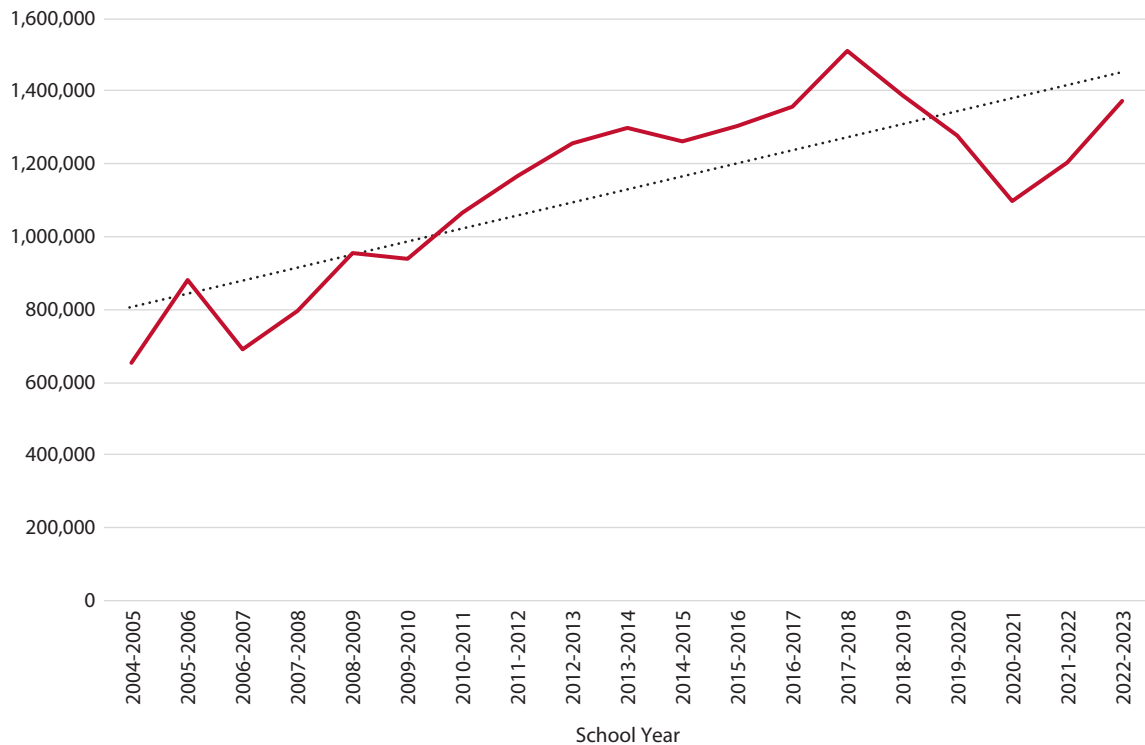

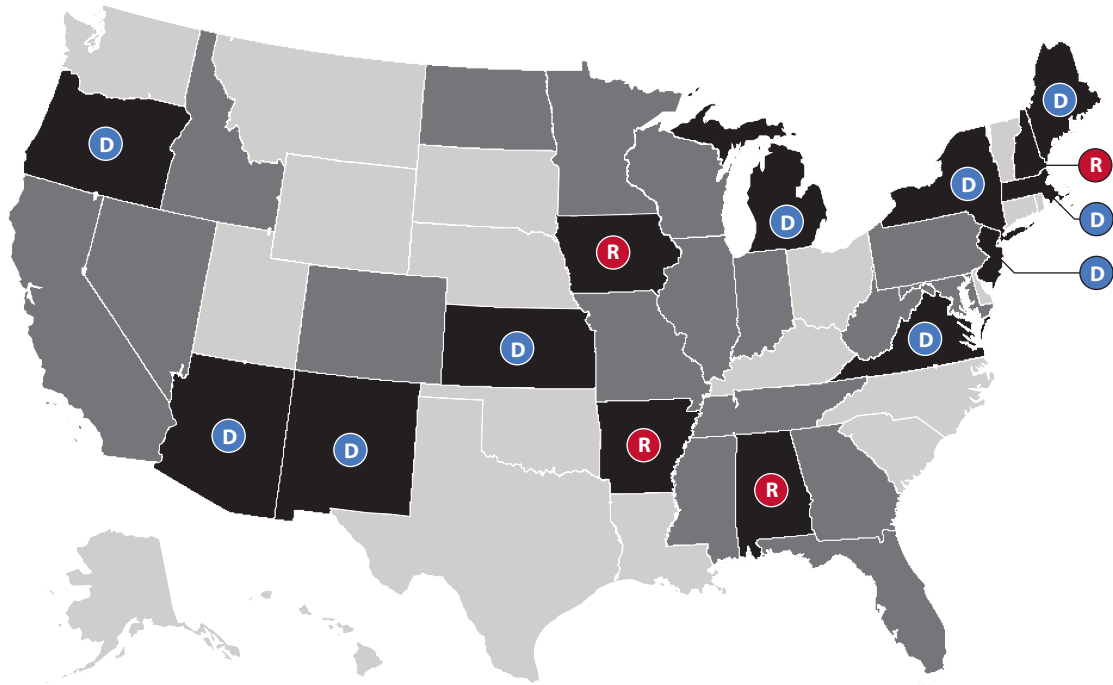
U.S. Homeless Students (Pre-K to 12th Grade), 2004-2023

U.S. Economic Policy Uncertainty Index, Jan 1985-Nov 2025



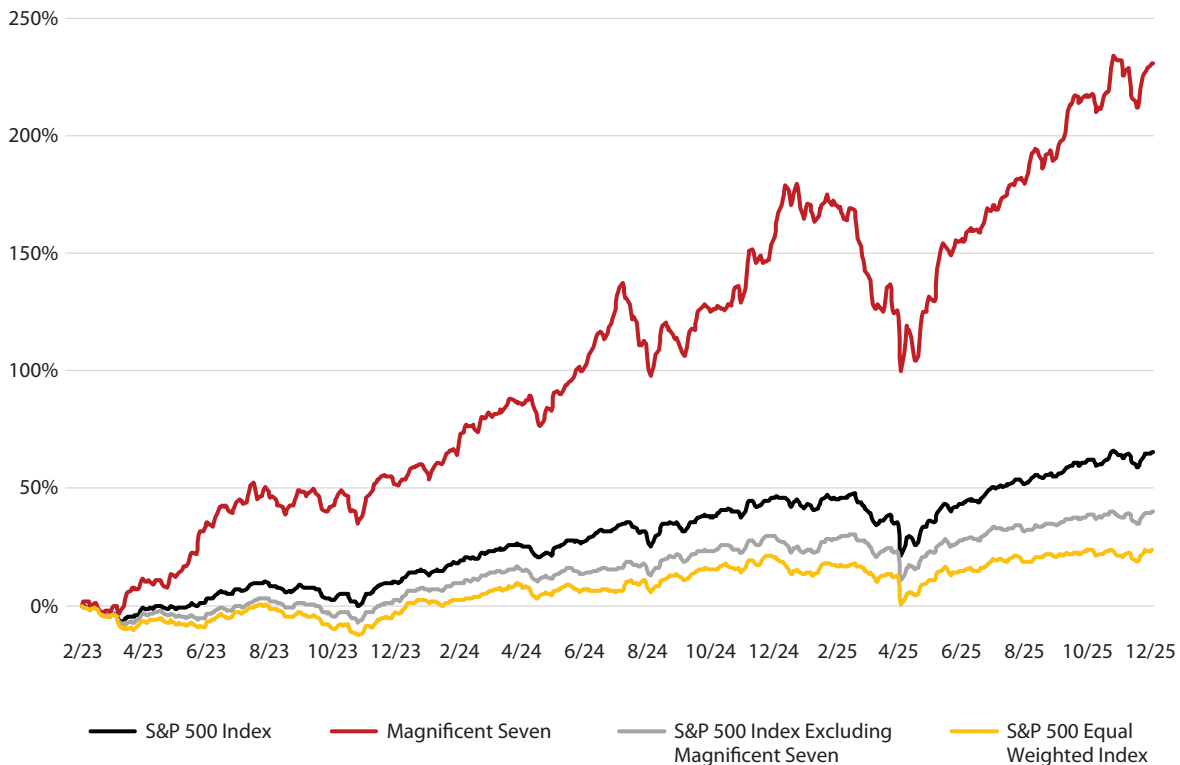

S&P 500 Index and Magnificent Seven Cumulative Percent Change, Feb 2023-Nov 2025

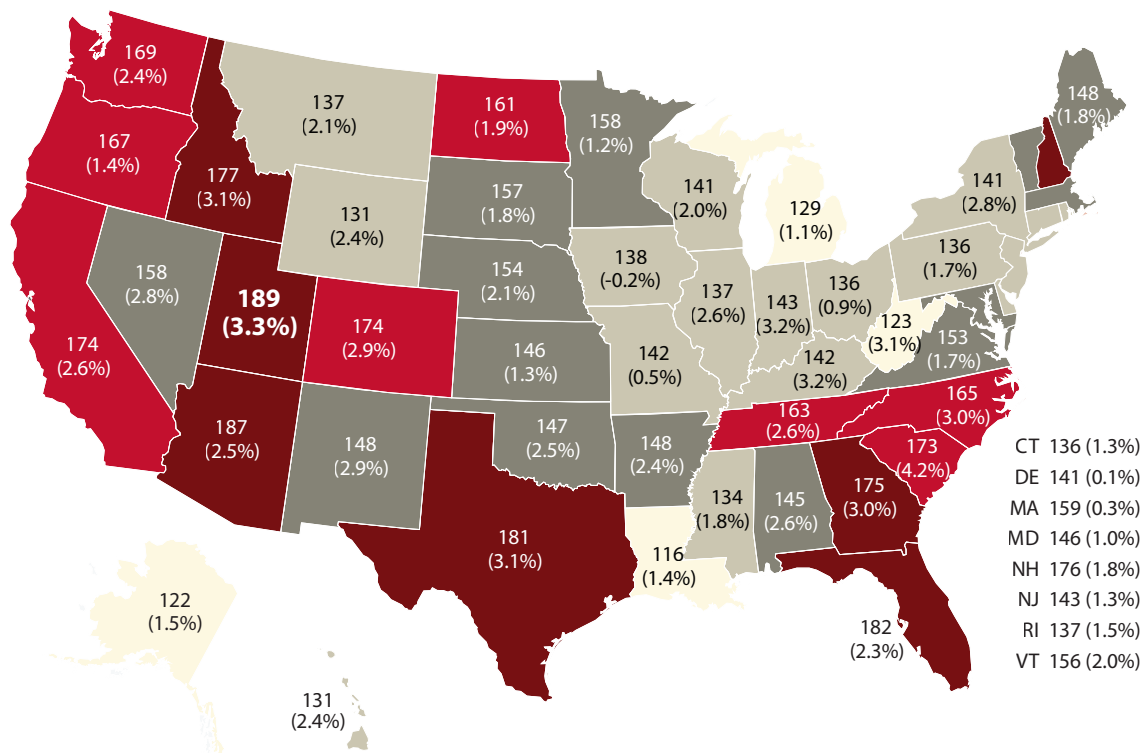

Value and Year-Over Percent Change

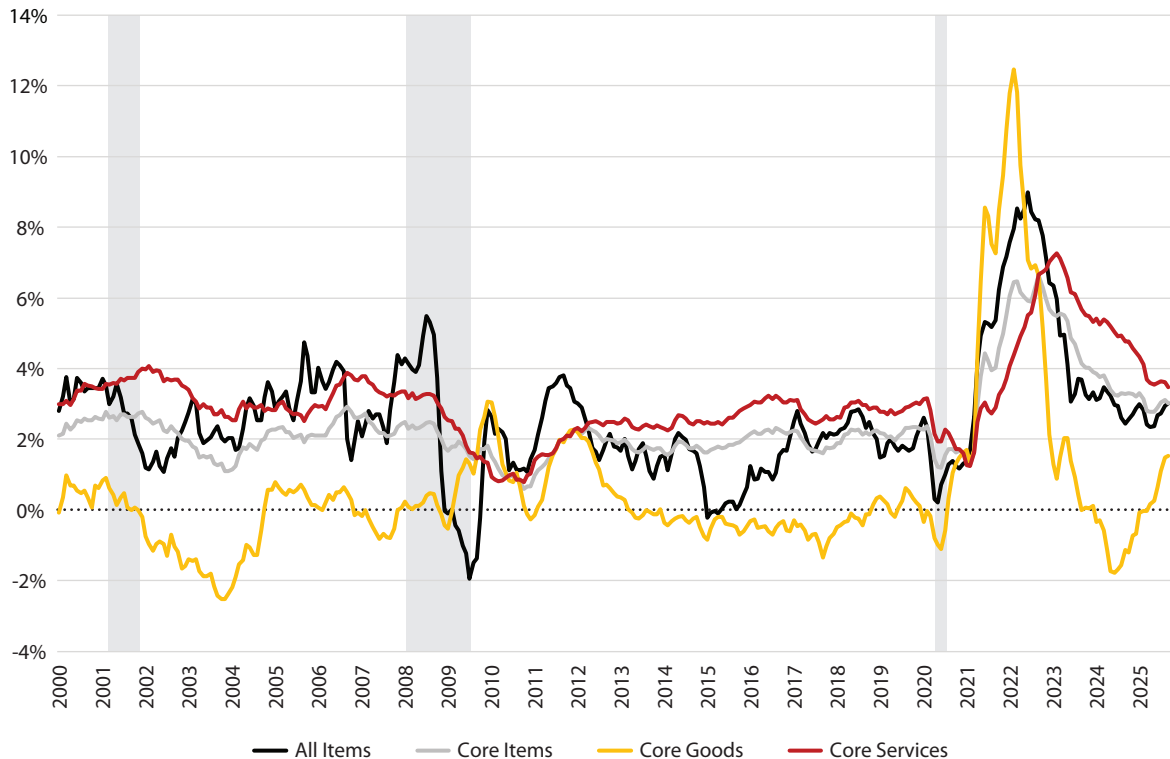

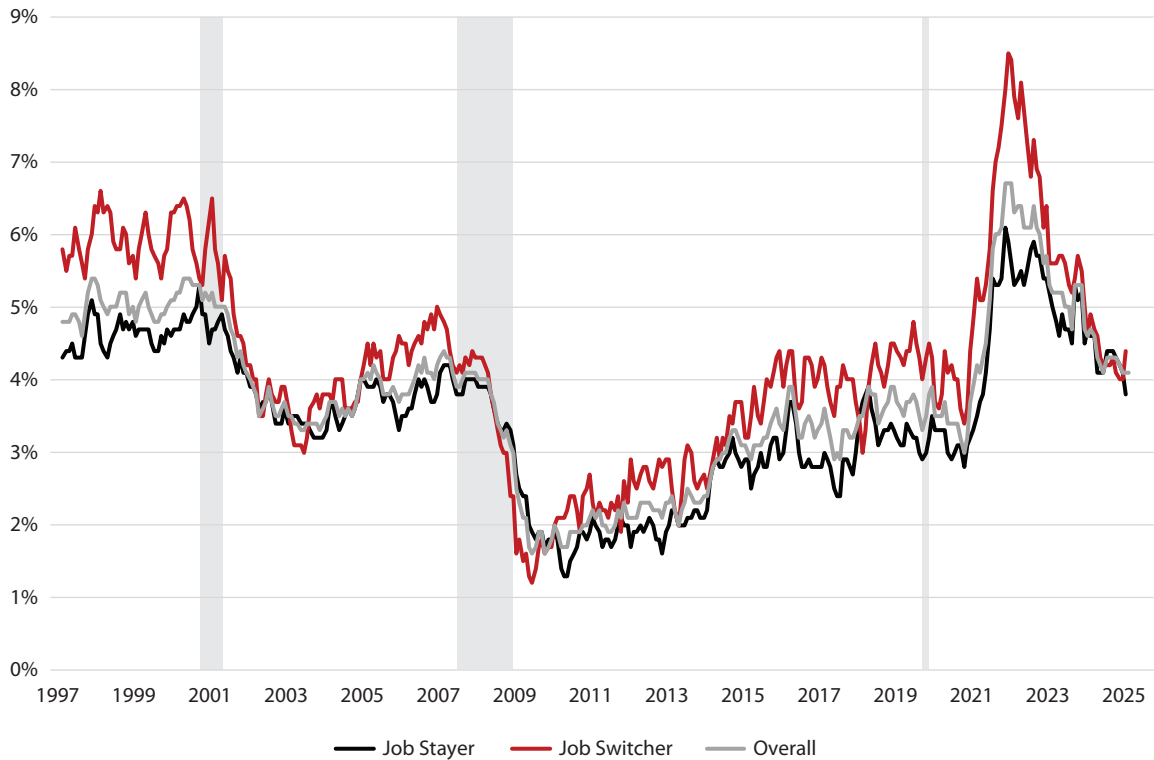

U.S. Median Wage Growth, Sept 1997-Sept 2025

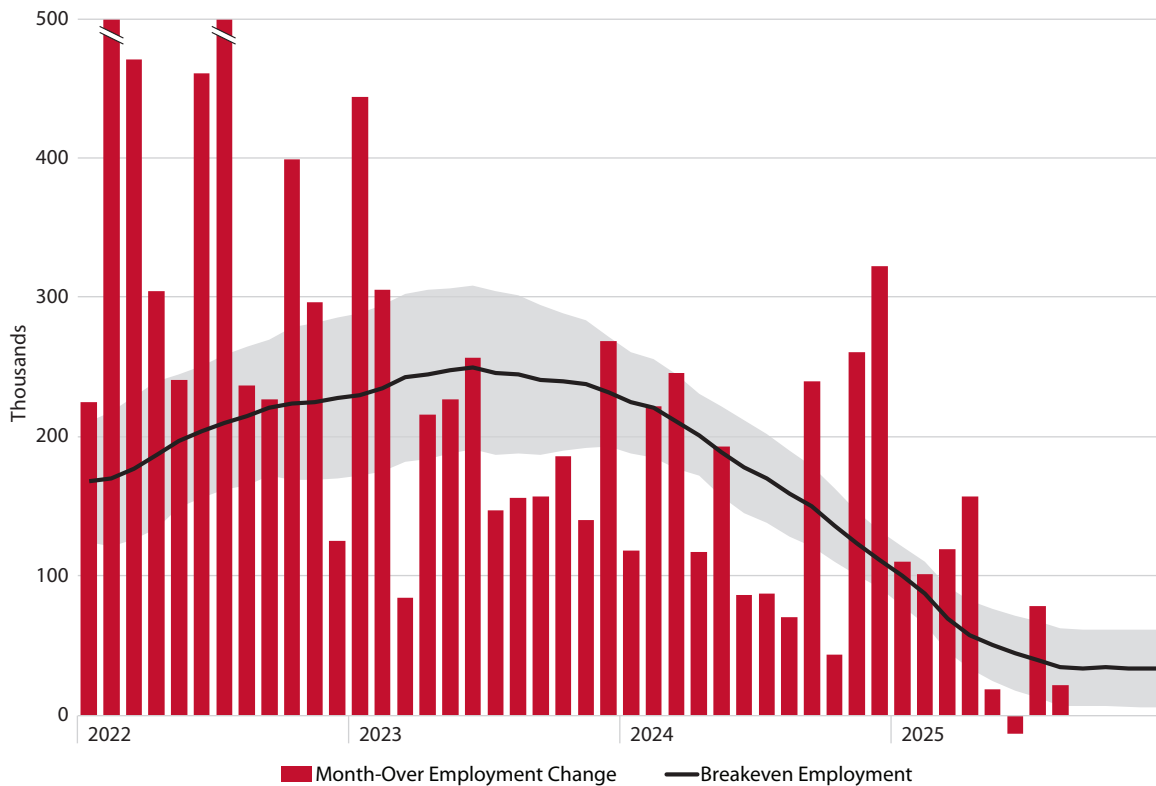
Three-Month Moving Average

U.S. Breakeven Employment Estimates and Month-Over Employment Change, Jan 2022-Aug 2025



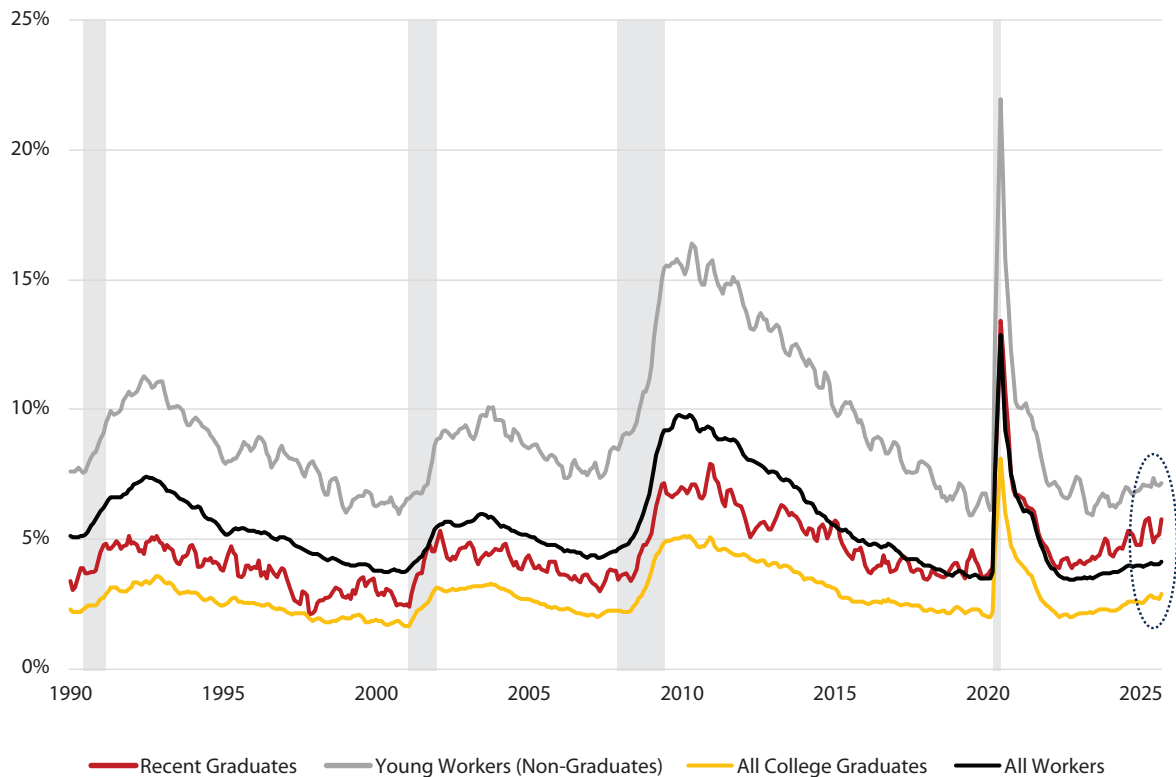

U.S. Unemployment Rates for Recent College Graduates vs. Other Groups, Jan 1990-Sept 2025

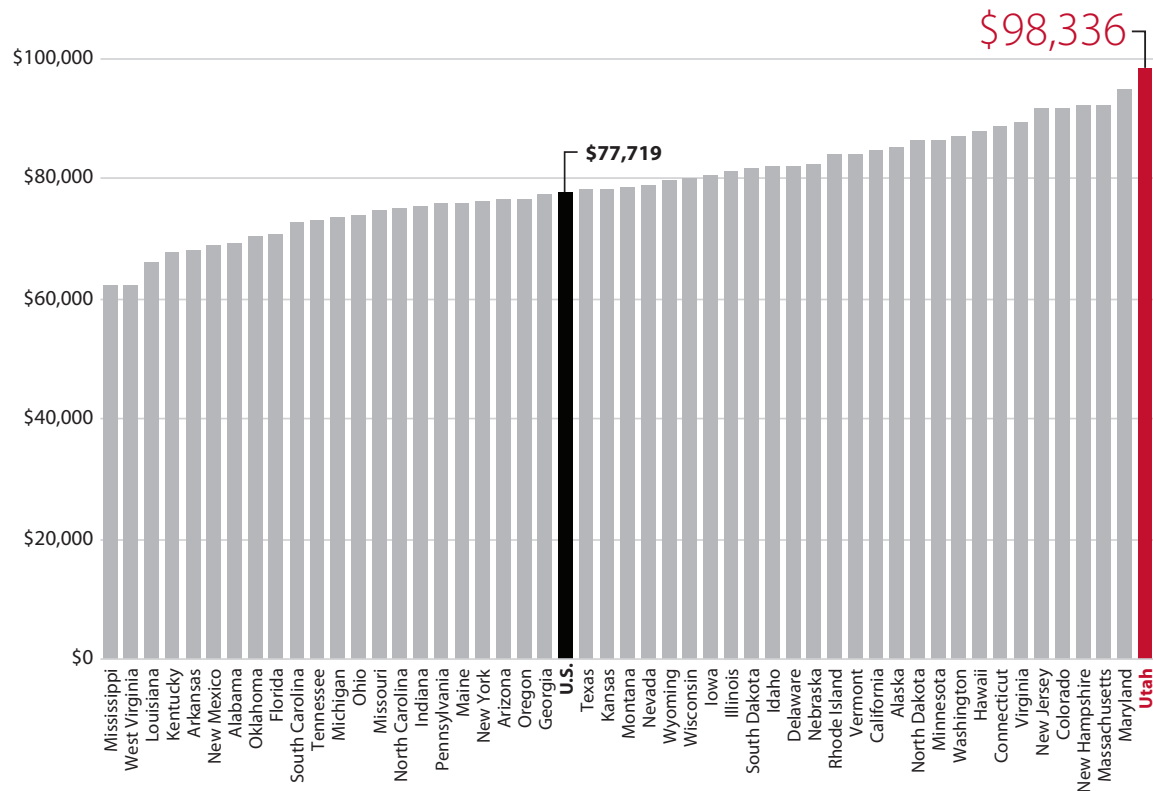

Median Household Income by State, 2023

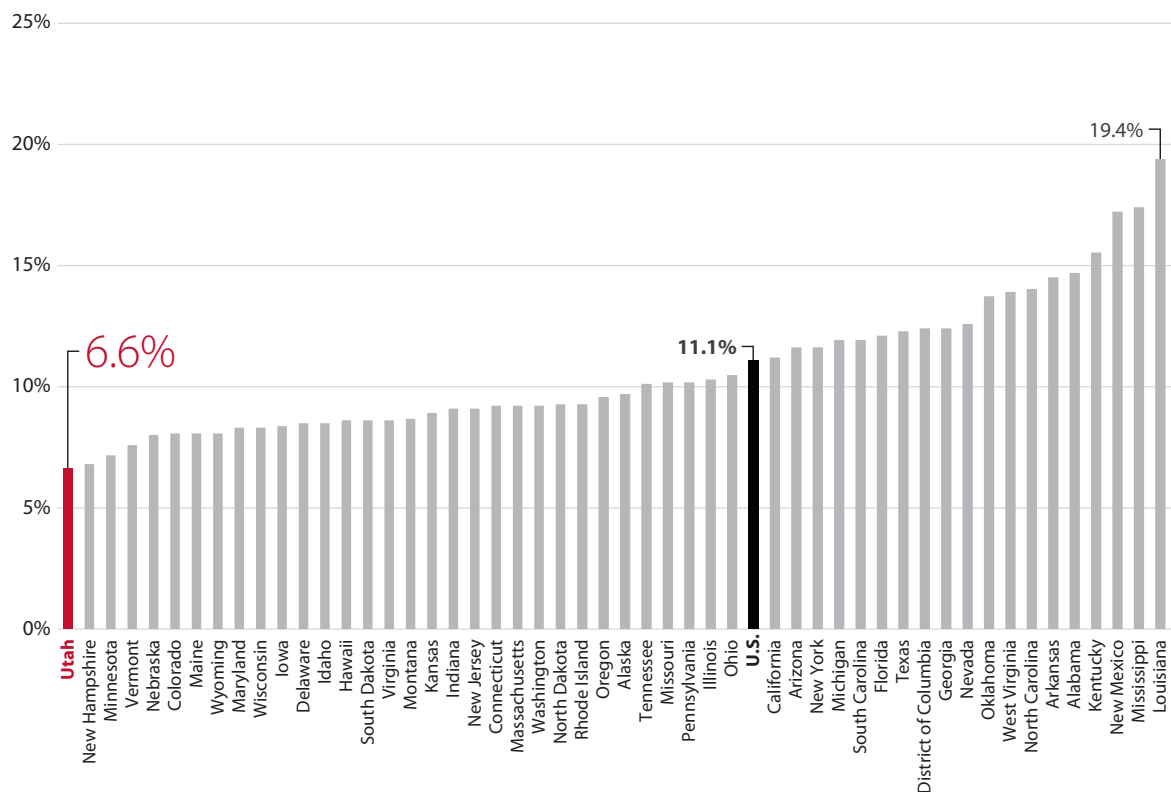

Poverty Rate by State, 2022-2024 Average

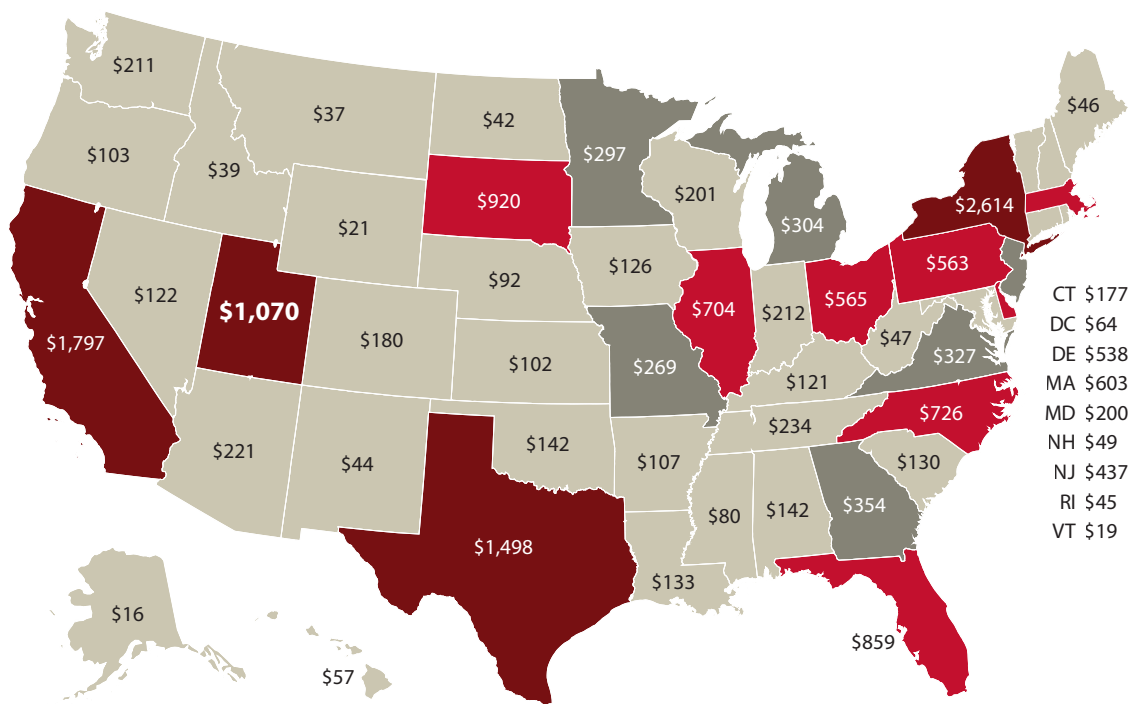

Dollars in Billions

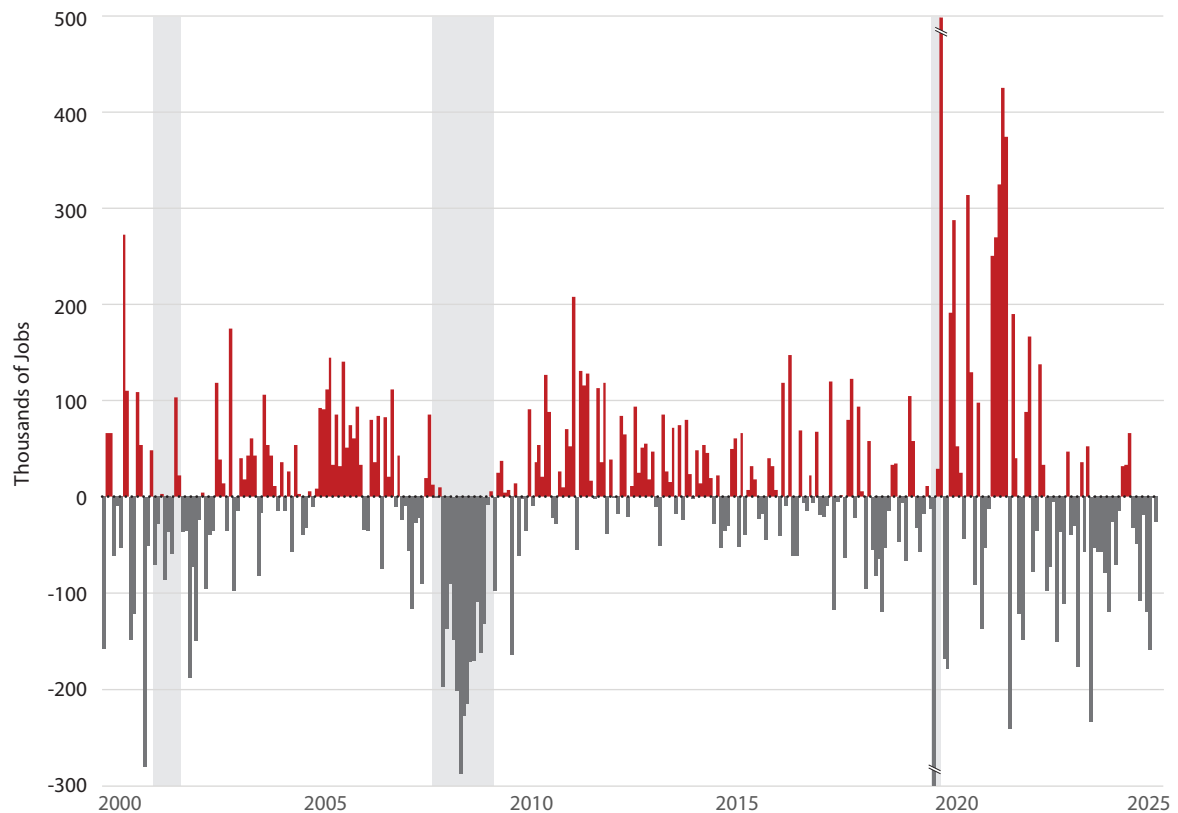

Revisions to Preliminary U.S. Current Employment Situation (CES) Monthly Job Estimates, Jan 2000-Sept 2025

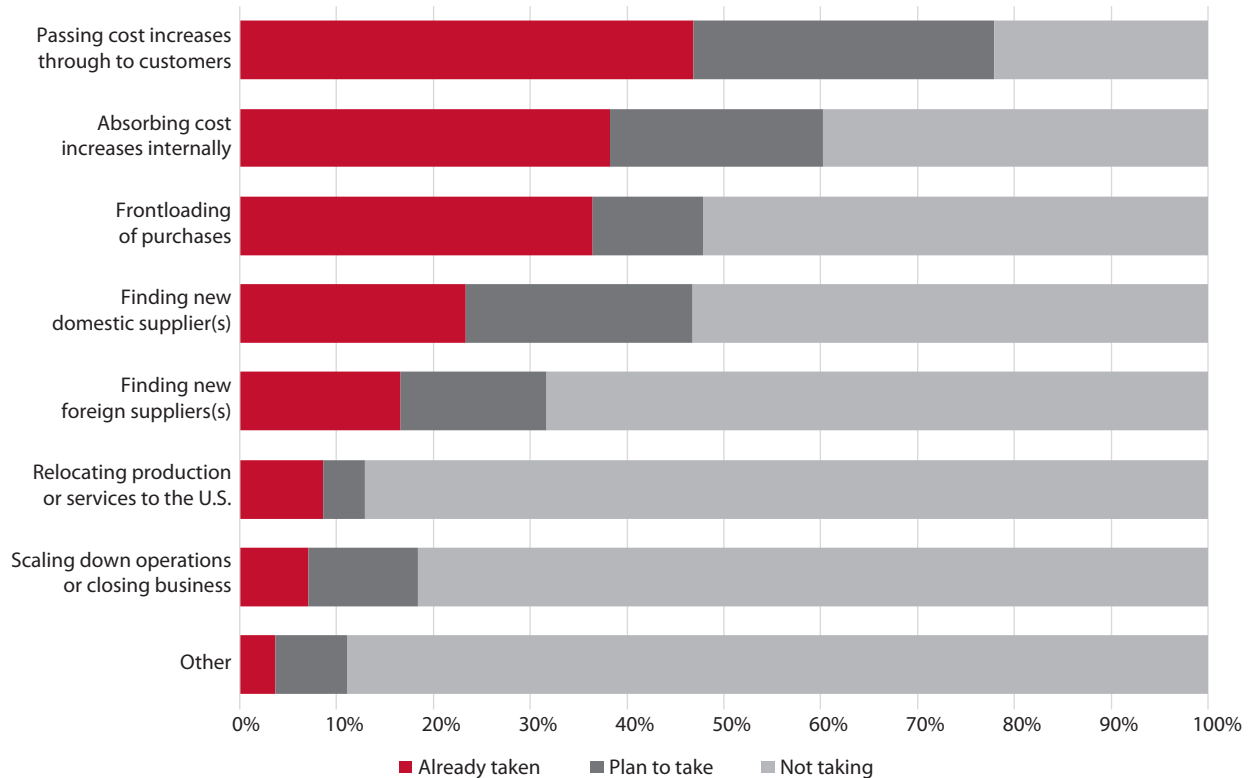
Differences Between Initial and Latest Estimates

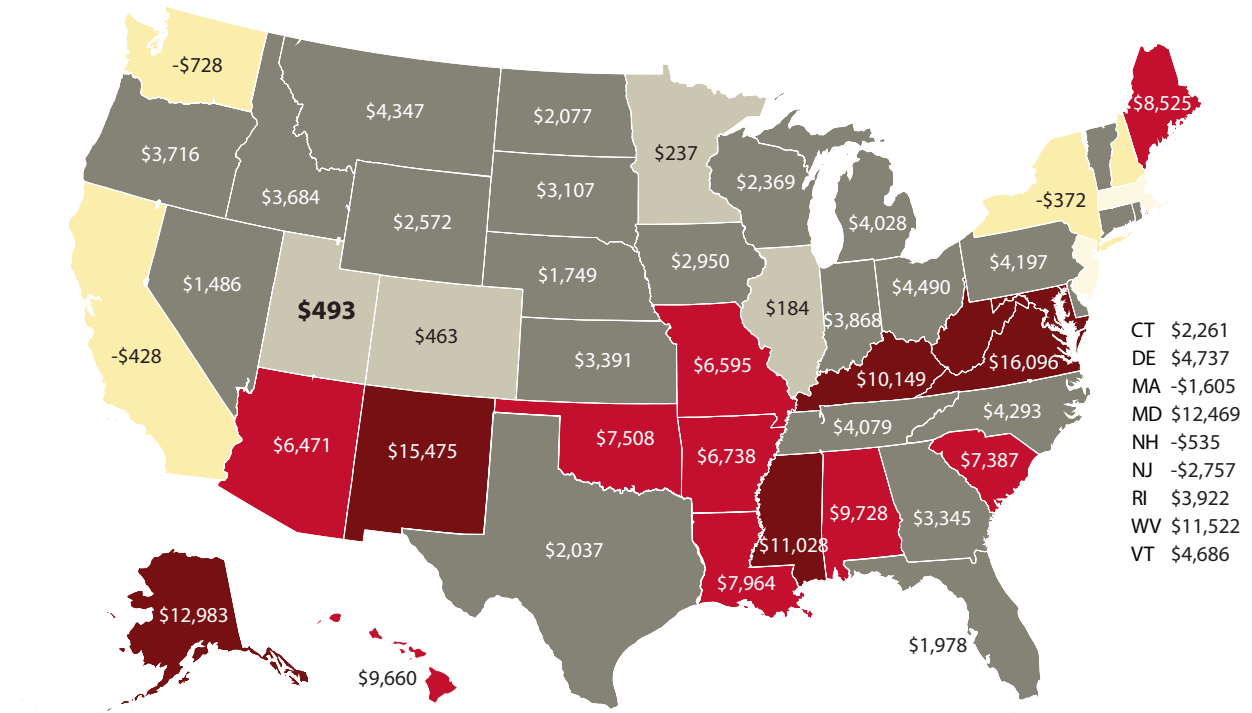
Firm Responses to Higher Tariffs, Survey Responses, August 2025

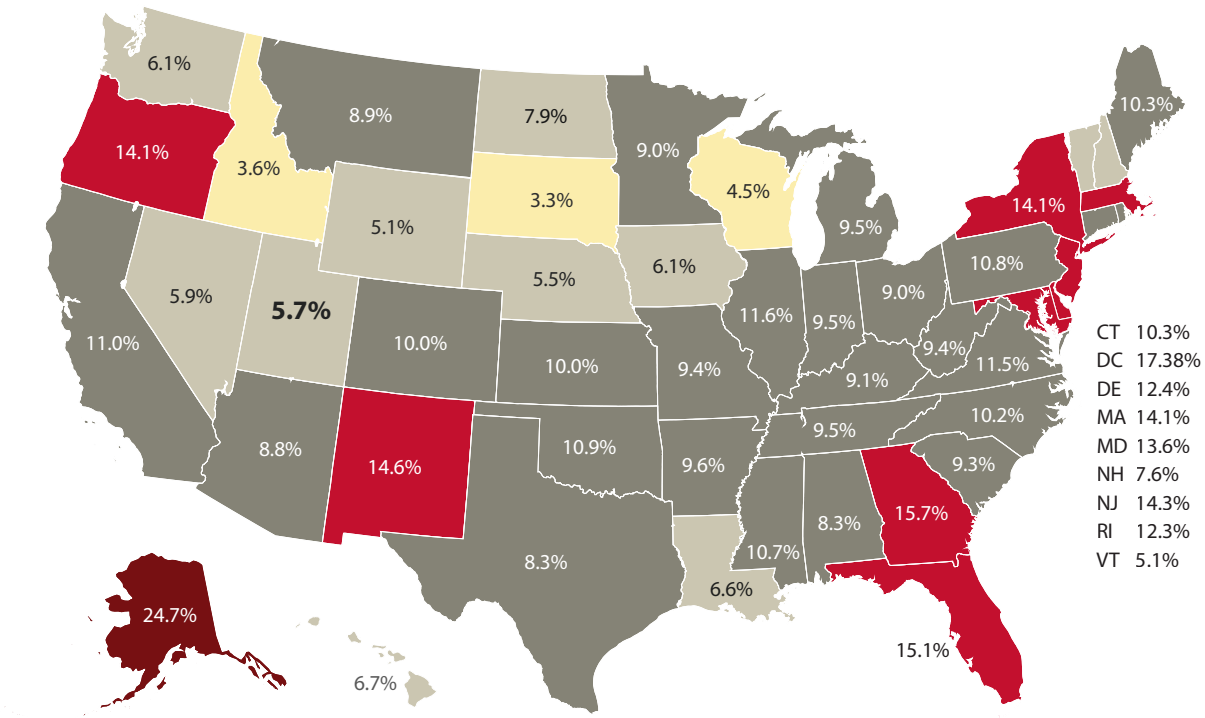
Per Capita Federal Balance of Payments by State, FFY2023

Supplemental Nutrition Assistance Program (SNAP) Error Rates by State, FFY2024

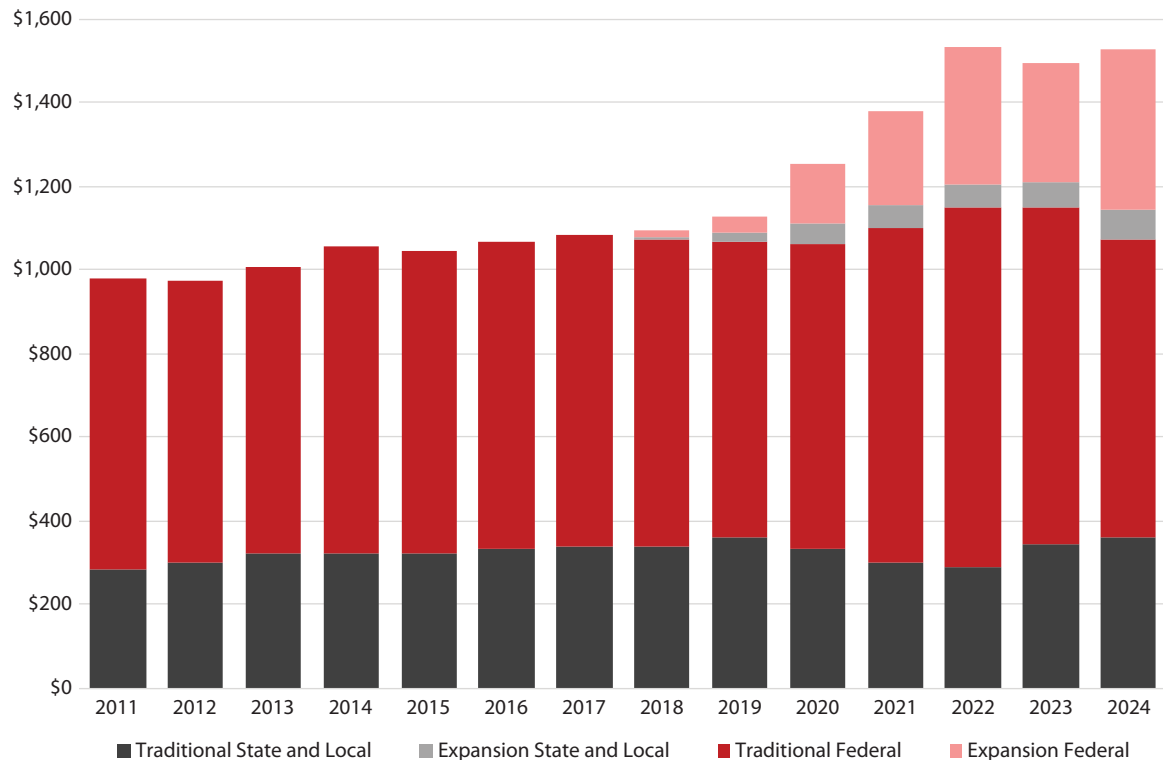

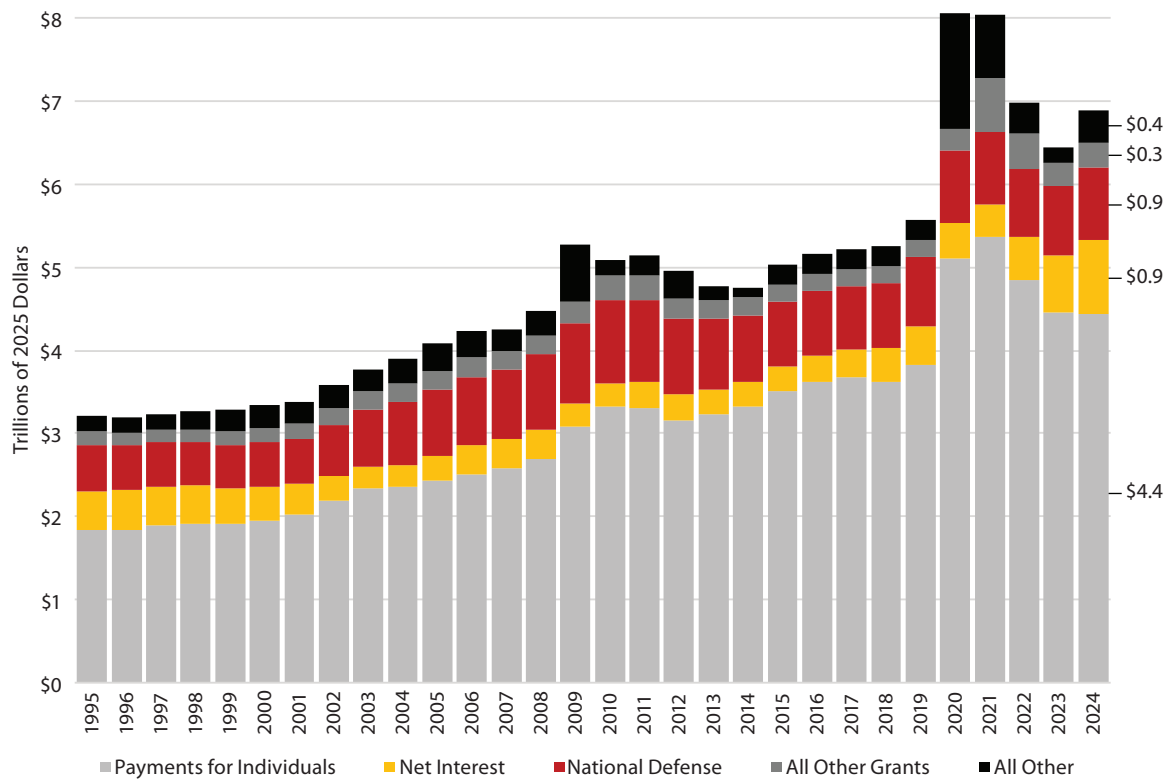
Real Utah Medicaid Spending per Capita, by Federal or State and Local Funds, FY2011-2024

Real Federal Outlays by Category, FFY1995-2024

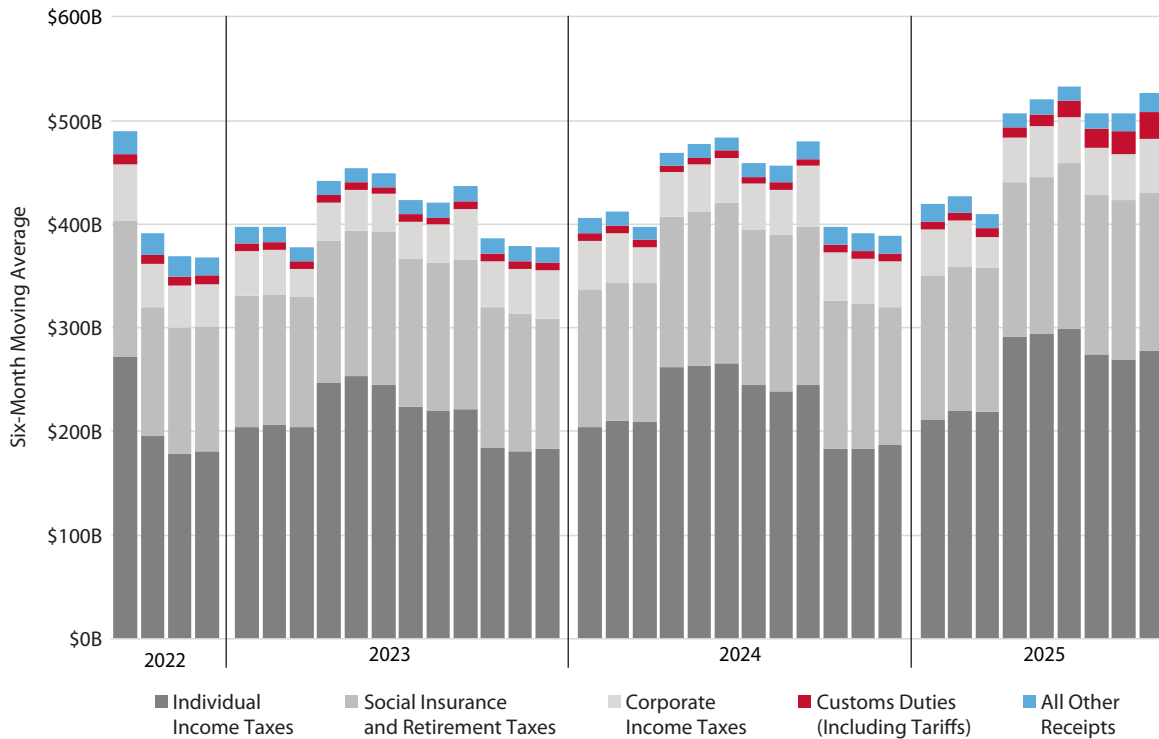

Federal Net Receipts by Category, Sept 2022-Sept 2025

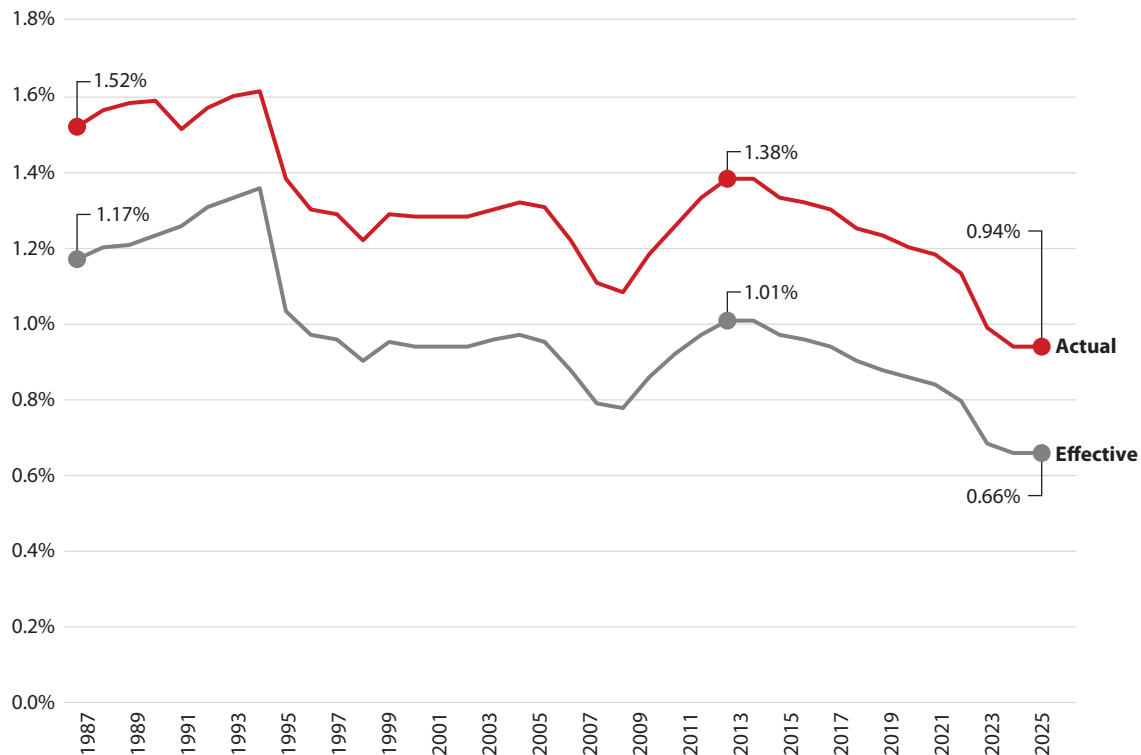
Six-Month Moving Average

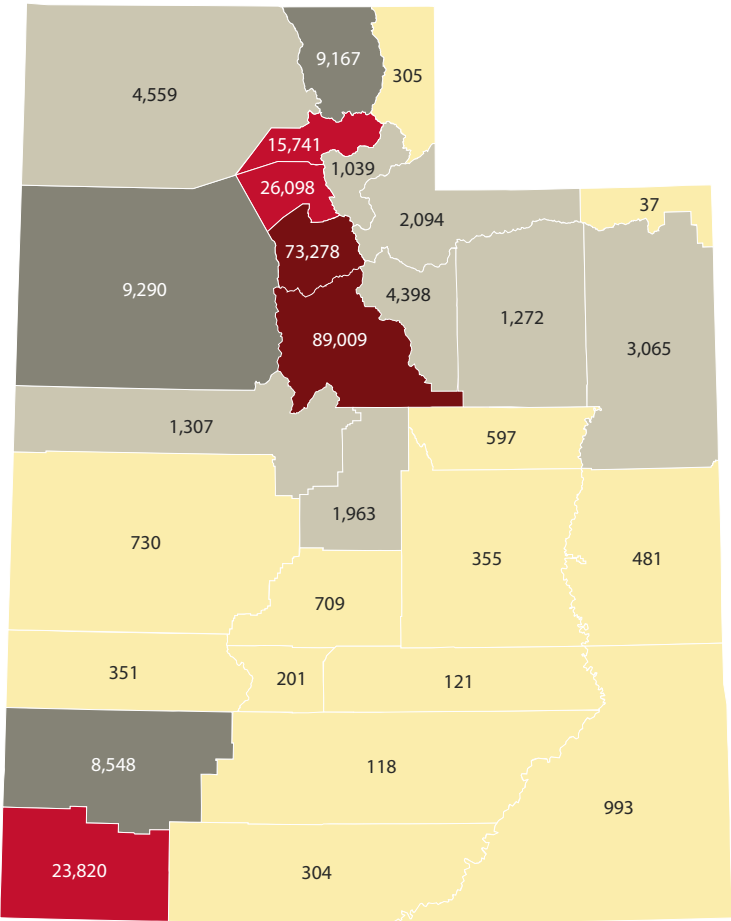
Utah Actual and Effective Property Tax Rates for All Taxable Property, FY1987-2025

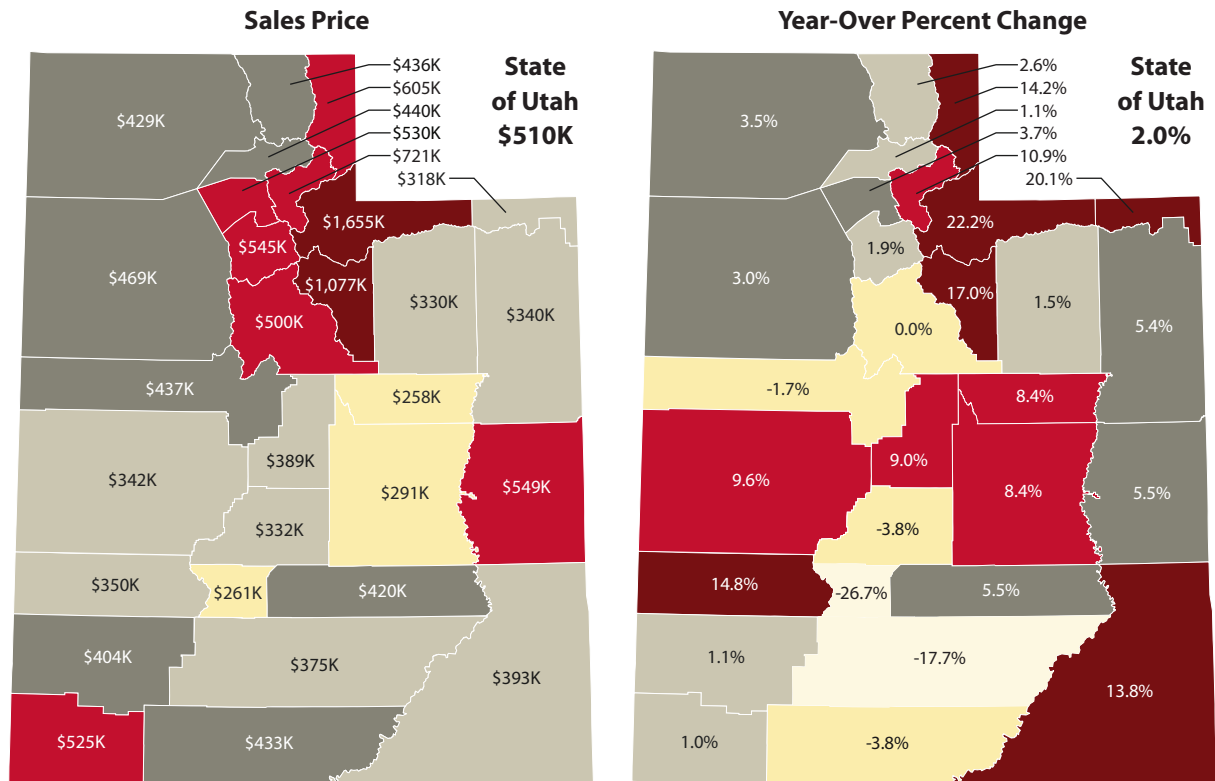
Projected Household Growth by County, 2025-2035

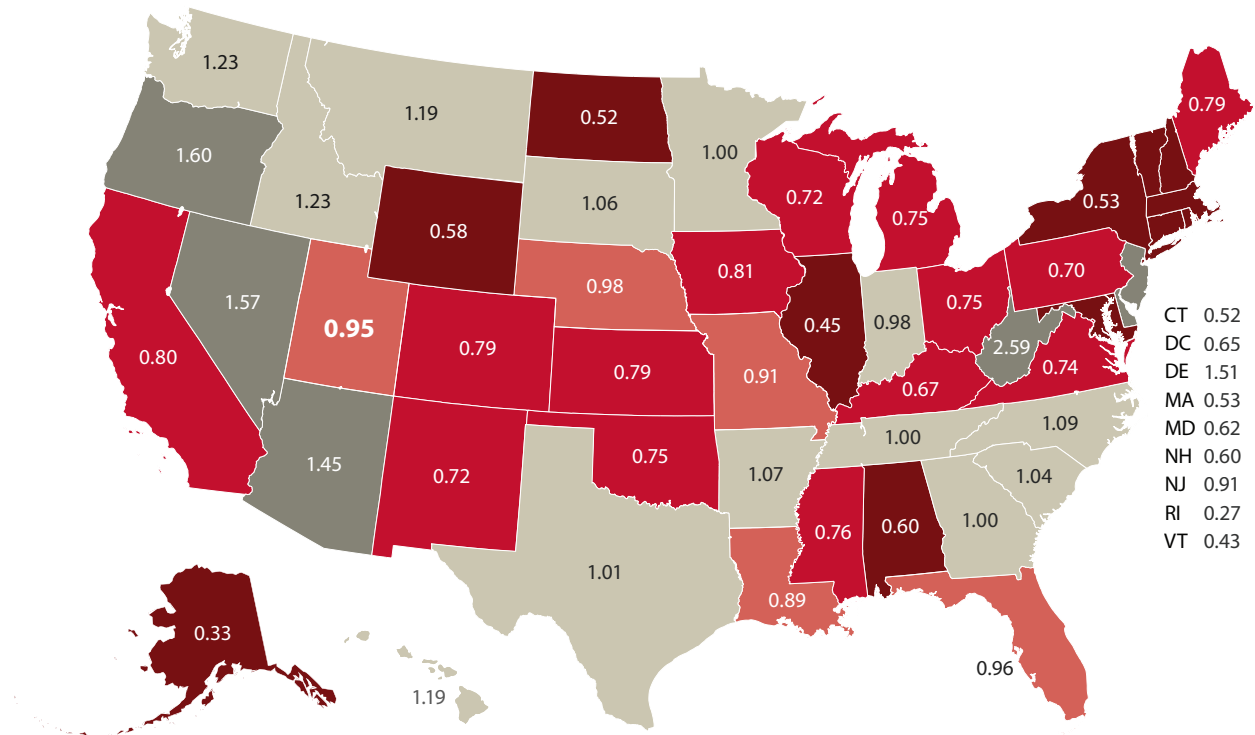
Median Home Sales Price and Year-Over Percent Change by County, September 2025

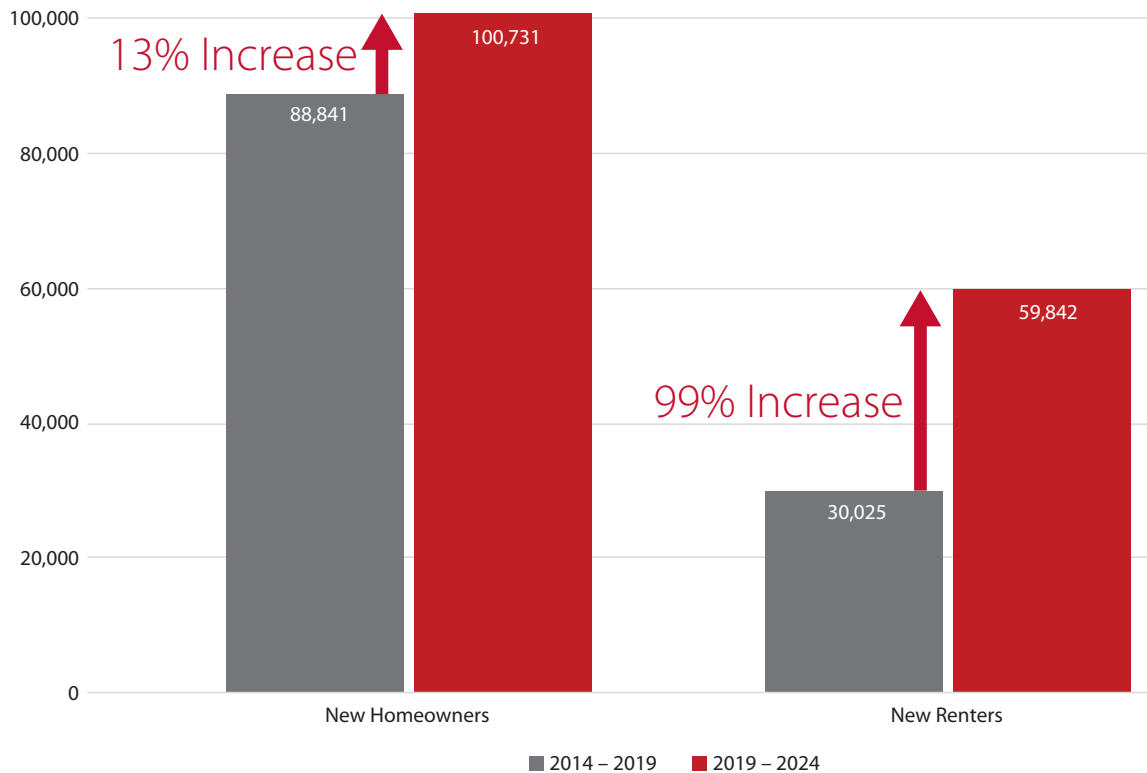
Total New Households Divided by New Housing Starts by State, 2020-2024

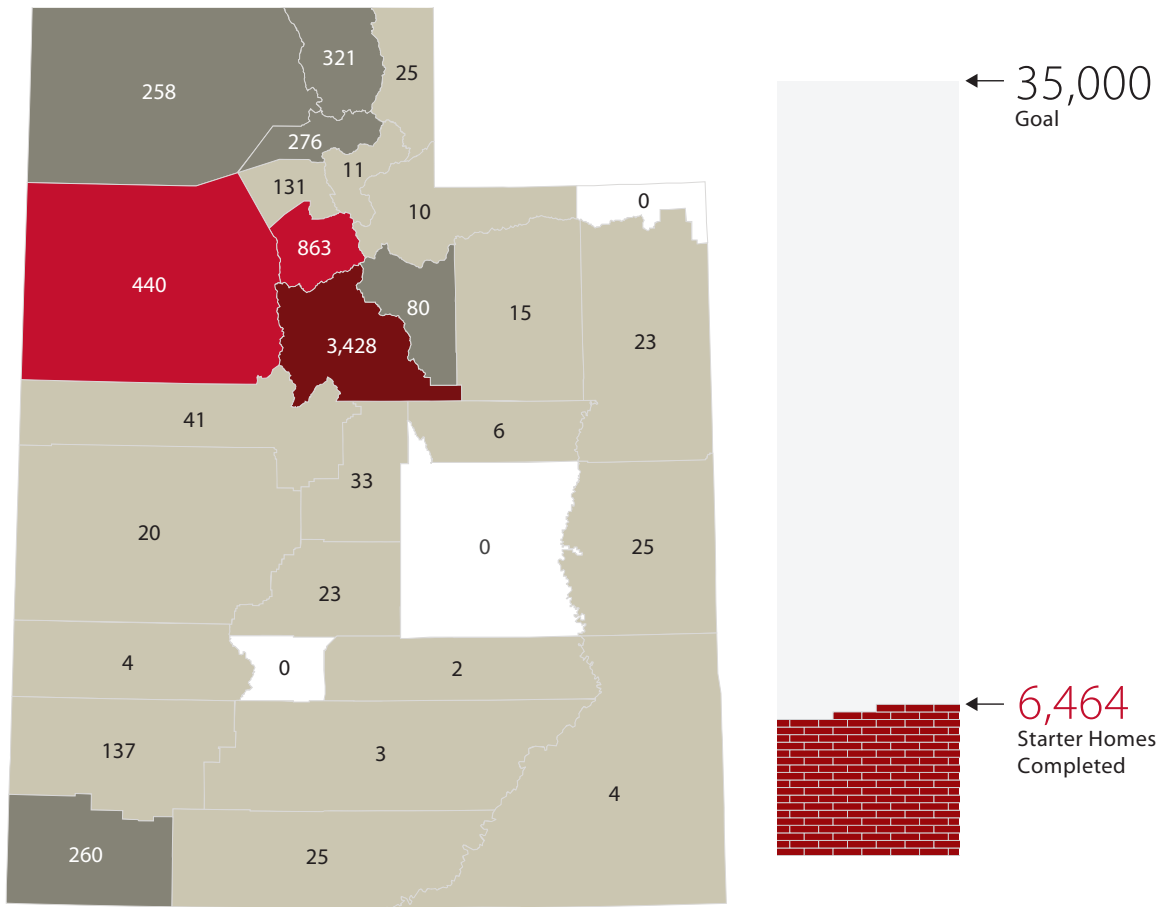
Increase of New Utah Homeowners and Renters, 2014-2019 and 2019-2024

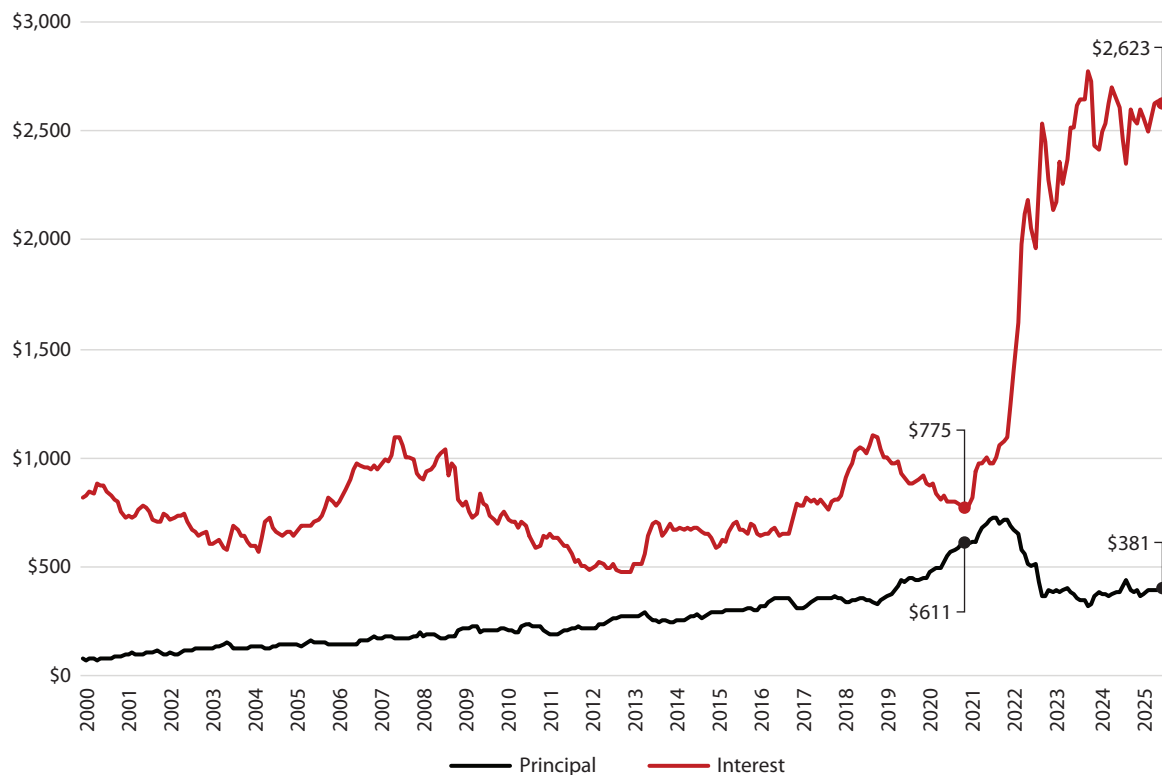
Newly Constructed Utah Homes Under \$450K, Jan 2024-Sept 2025

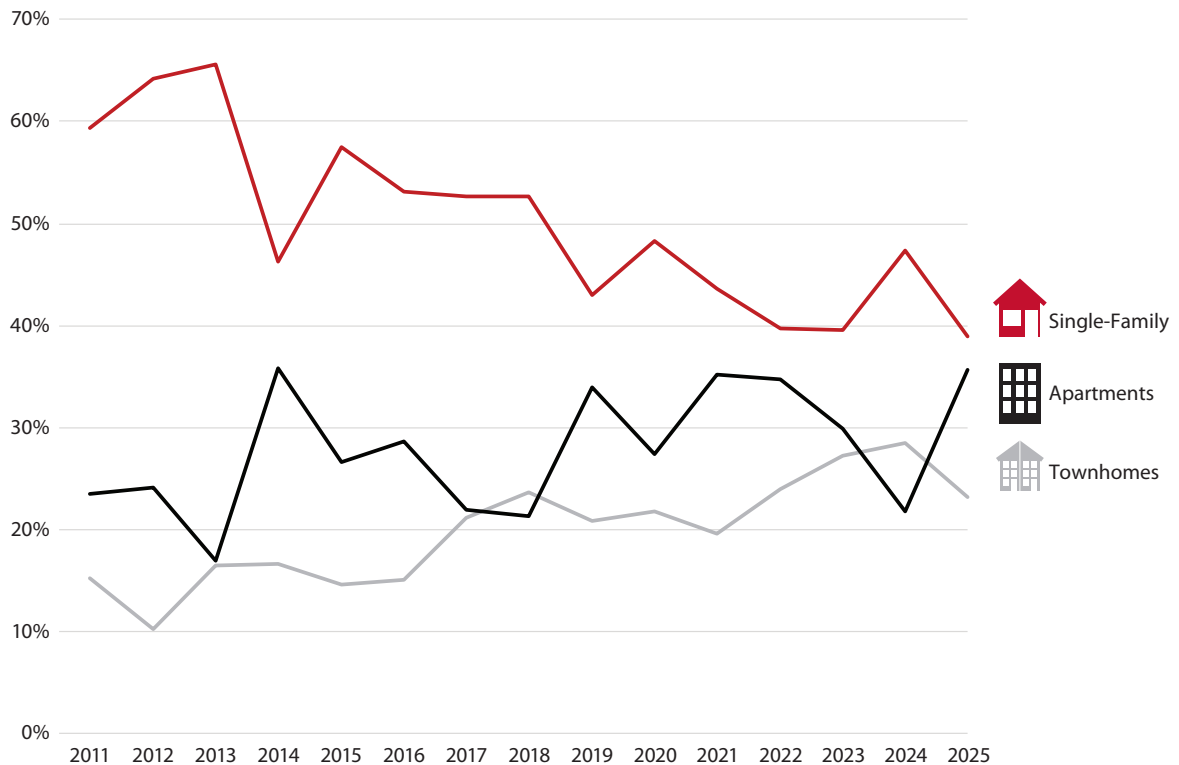
Utah Estimated Monthly Mortgage Payment for New Buyers, Interest vs. Principal, Jan 2000-July 2025

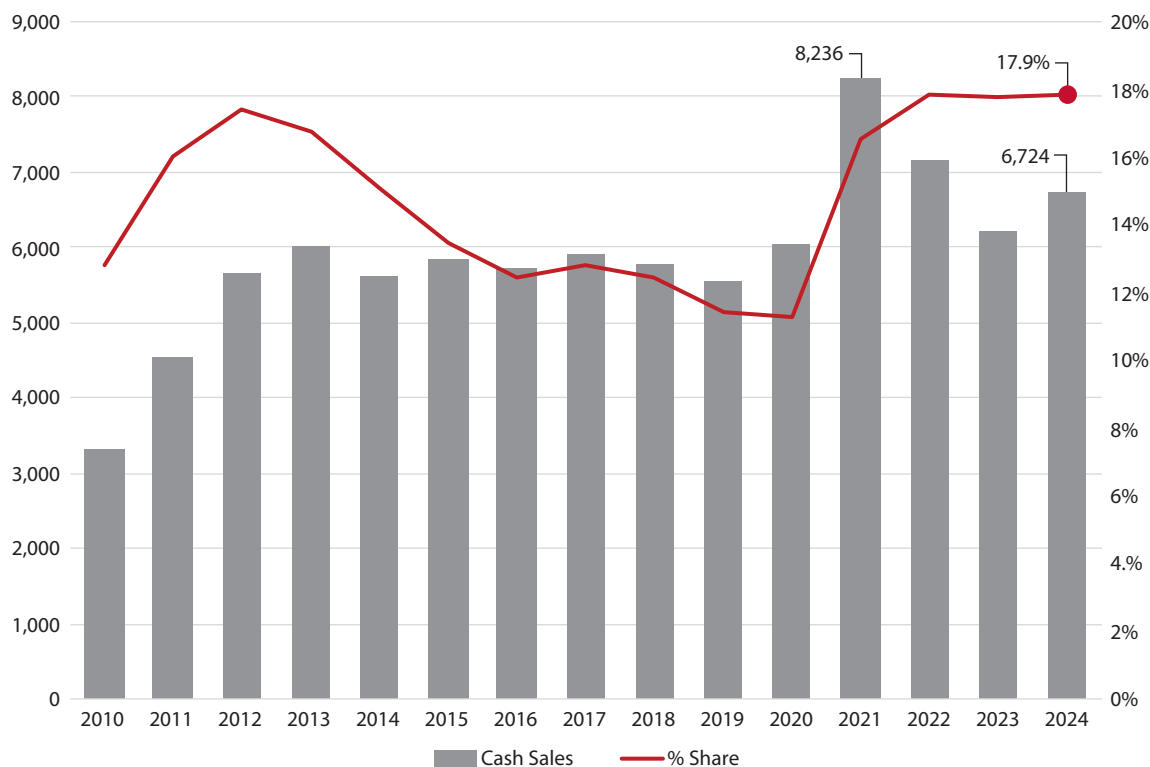
Share of Permitted Units by House Type in Utah, 2011-2025

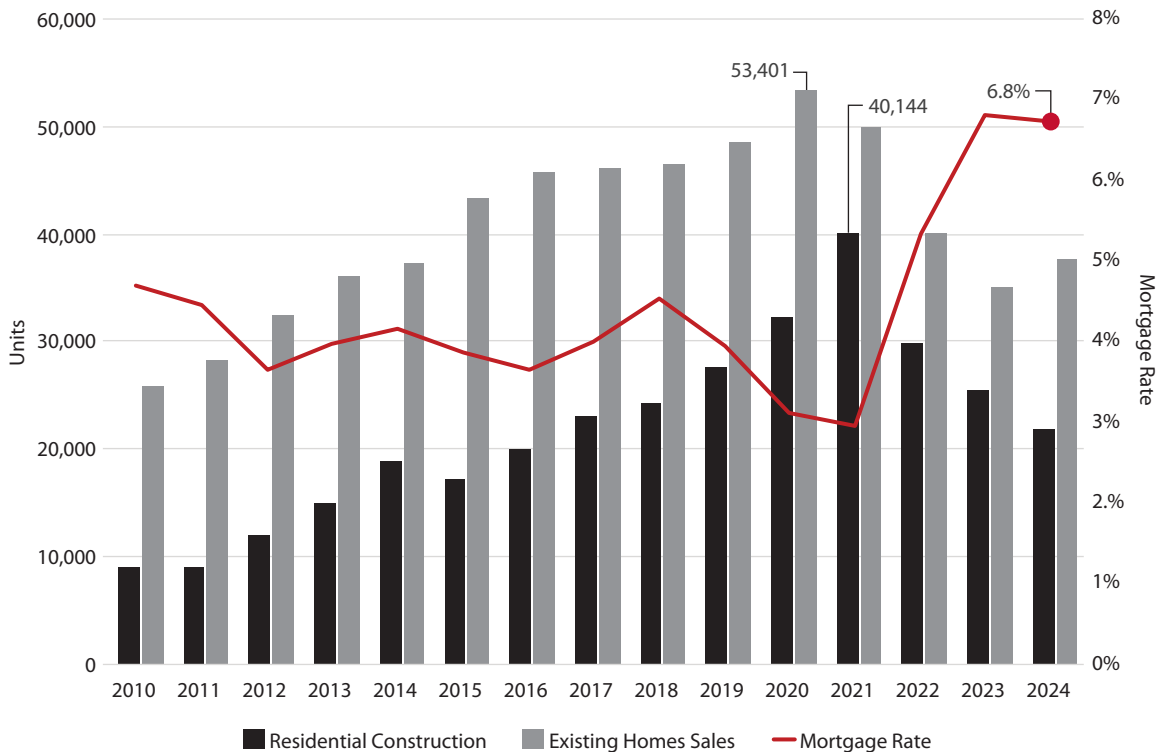
Number of Cash Sales of Residential Real Estate in Utah, 2010-2024

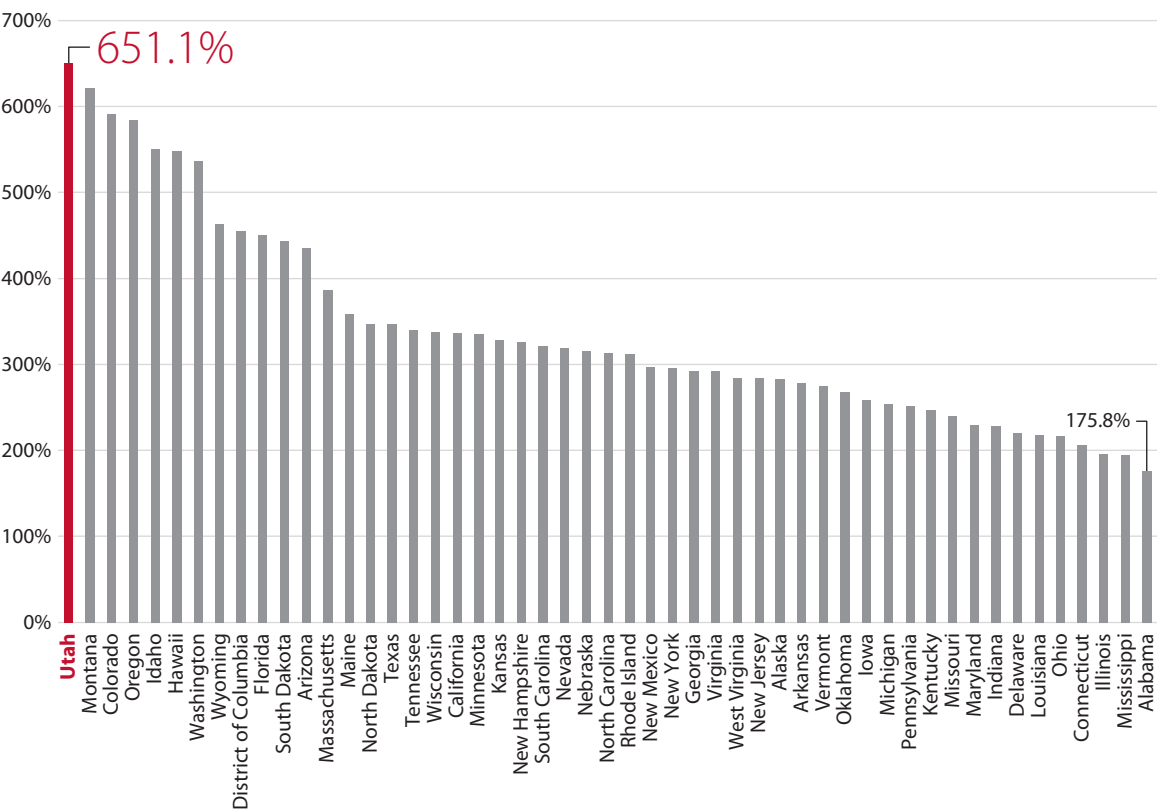
Interest Rates, New Home Construction, and Existing Real Estate Sales, 2010-2024

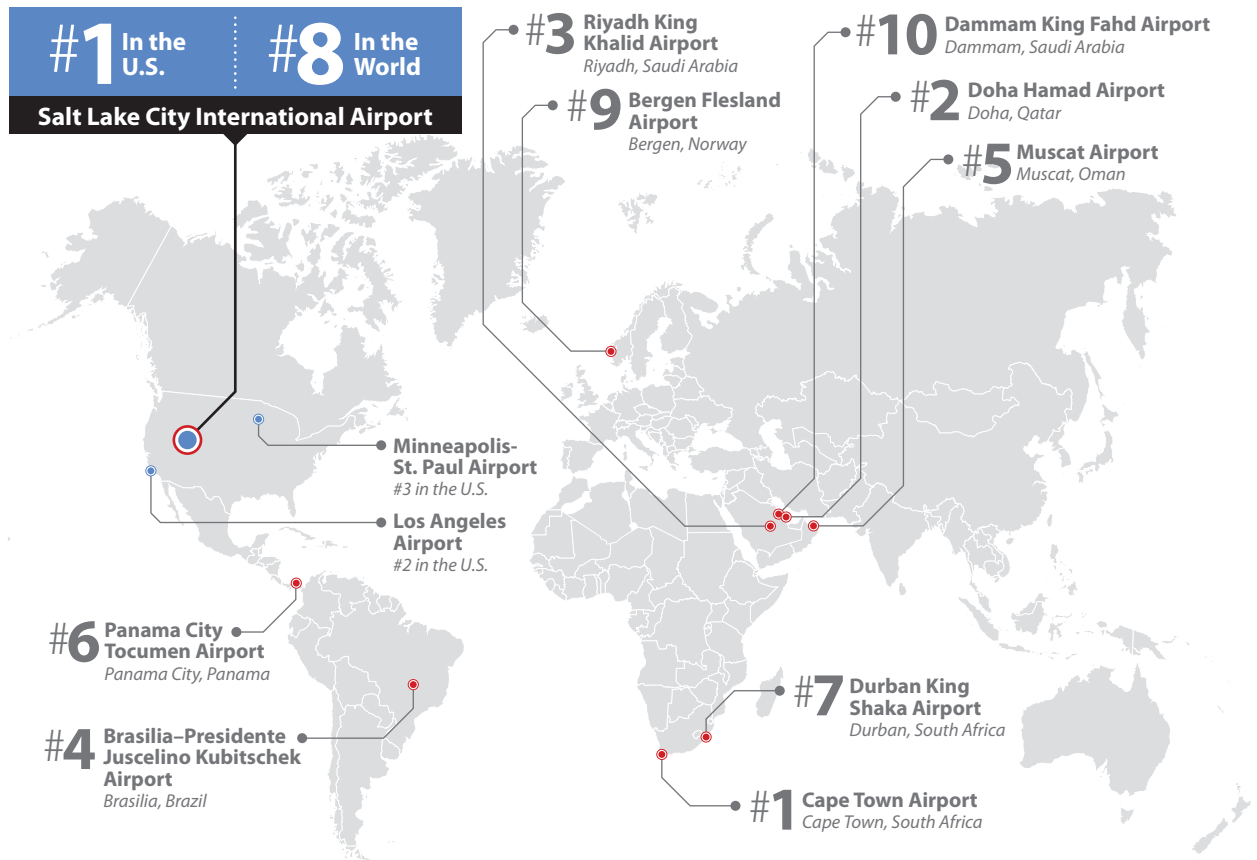
Percent Increase in FHFA's Housing Price Index by State, 1991-2024

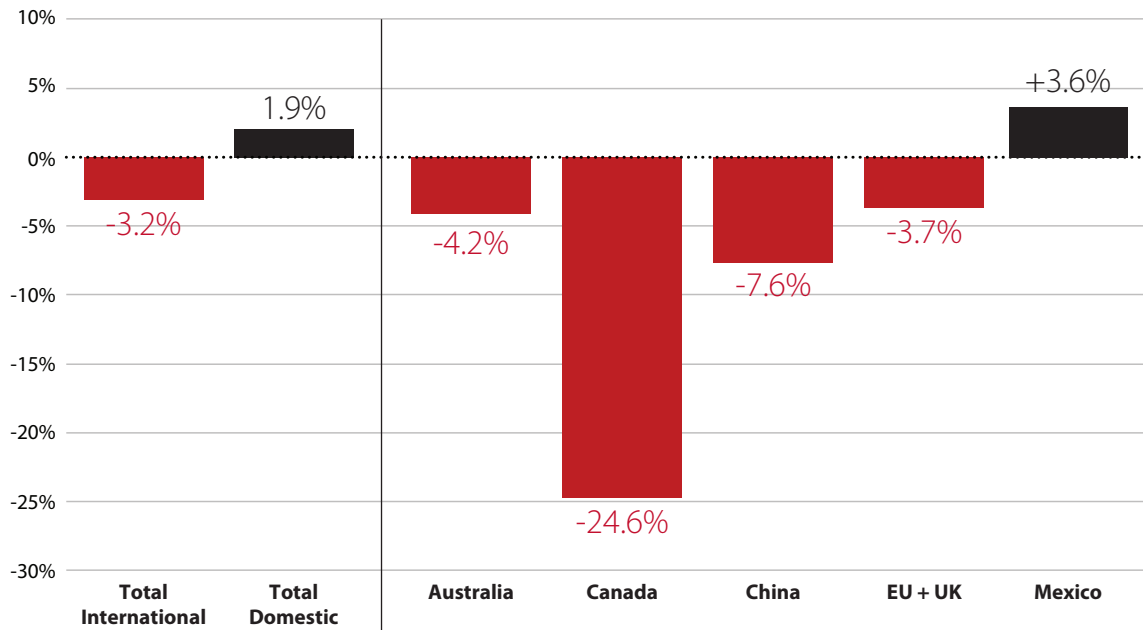
Global Airport Rankings, 2025

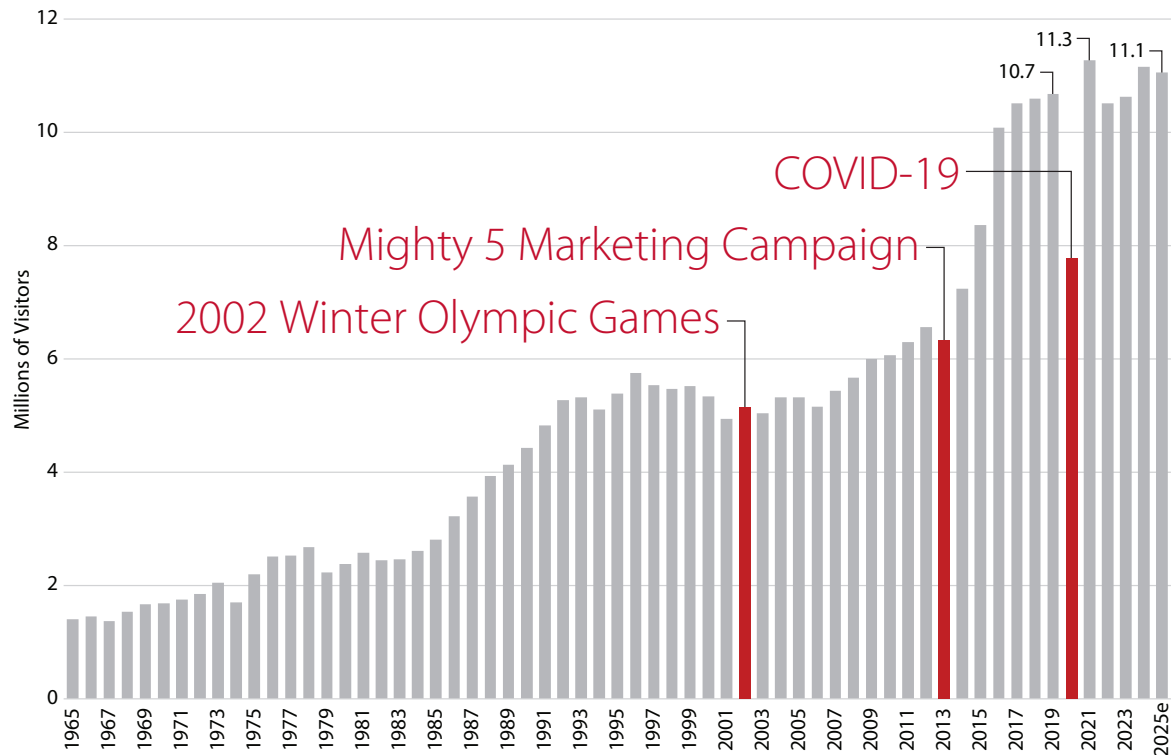
Utah Short-Term Rental Guests by Country of Origin, Year-Over Percent Change, 2025

Utah National Park Visitation, 1965-2025e

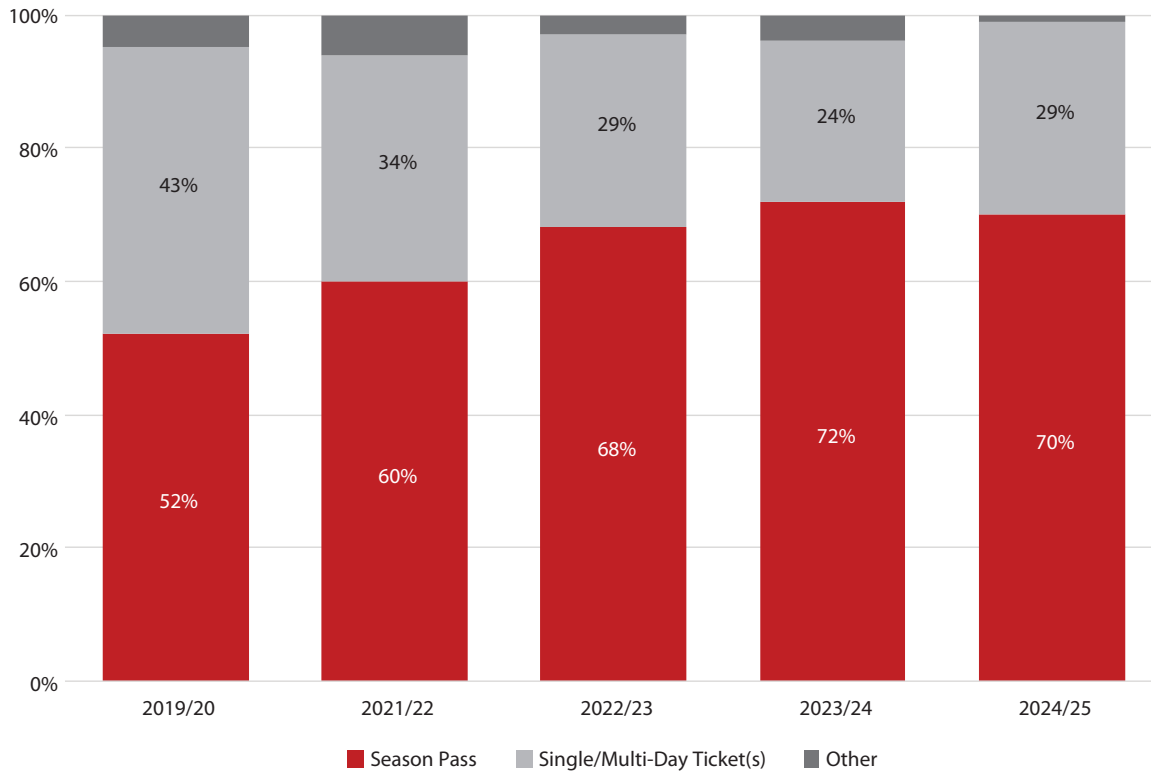

Utah Skier & Snowboarder Pass Usage, 2019/20-2024/25 Ski Seasons

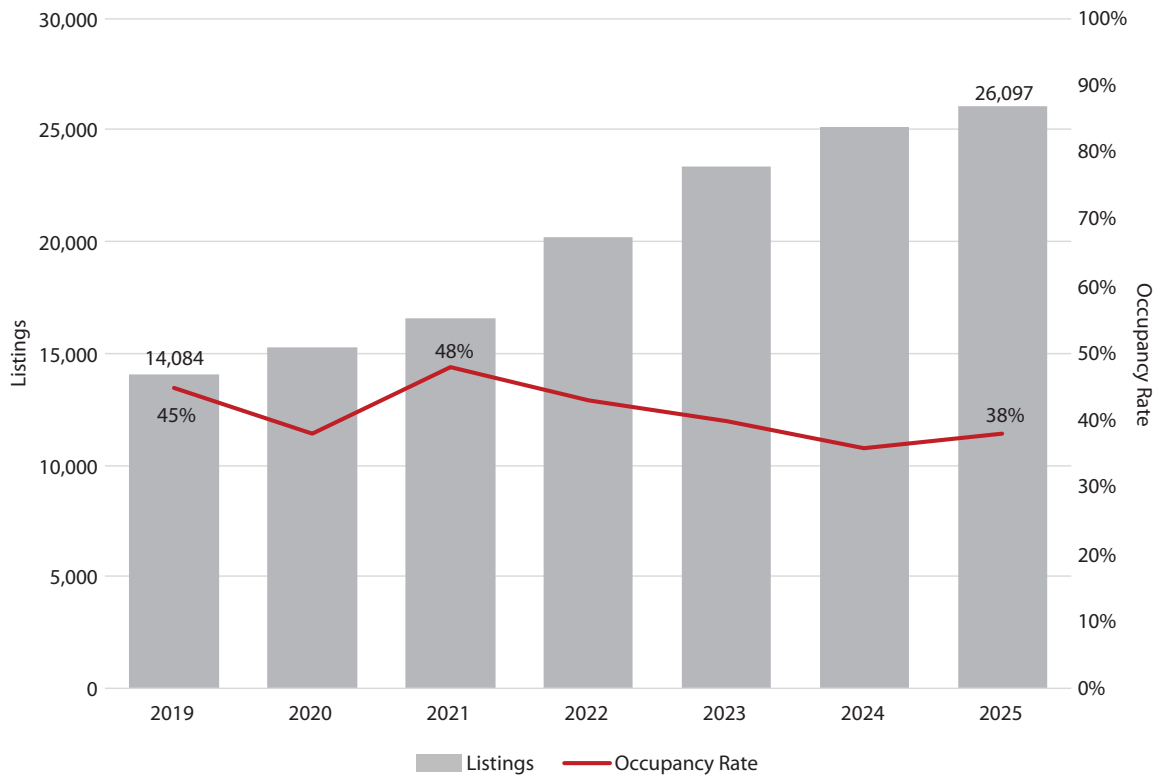

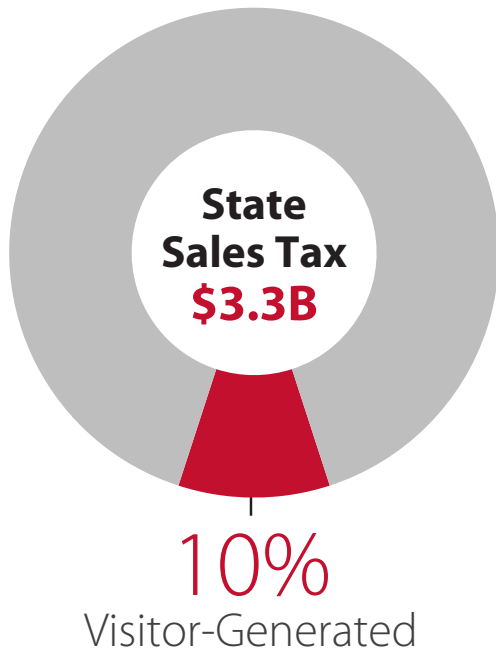
Utah Short-Term Rental Listings and Occupancy Rates, 2019-2025

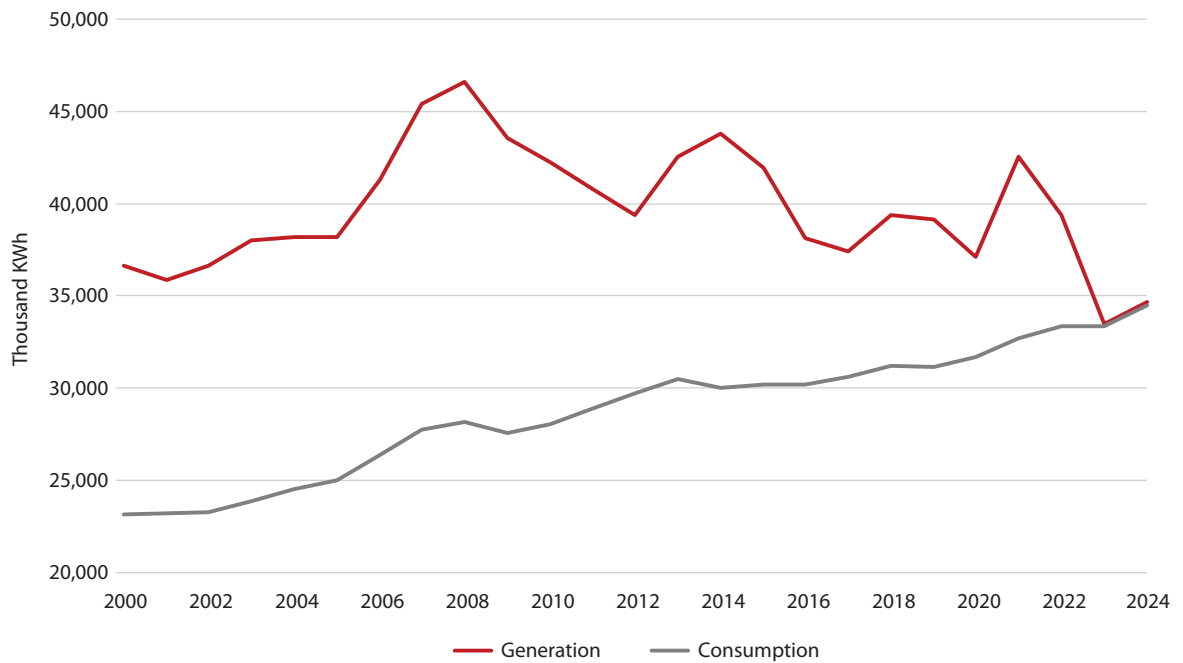
Estimated Visitor-Generated Share of Utah Tax Revenue, FY2024

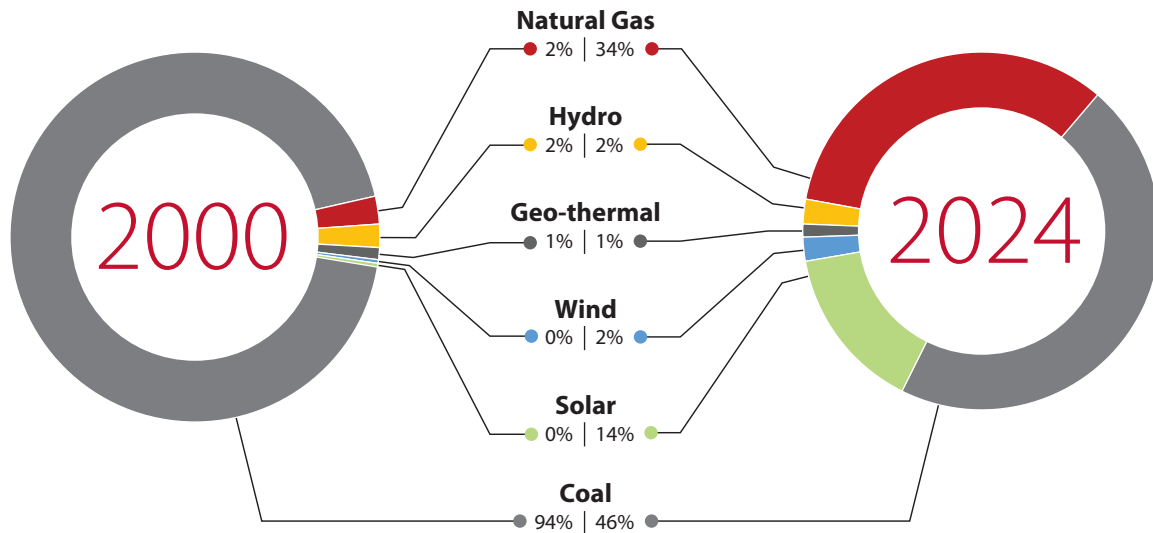
Utah Electricity Supply and Demand, 2000-2024

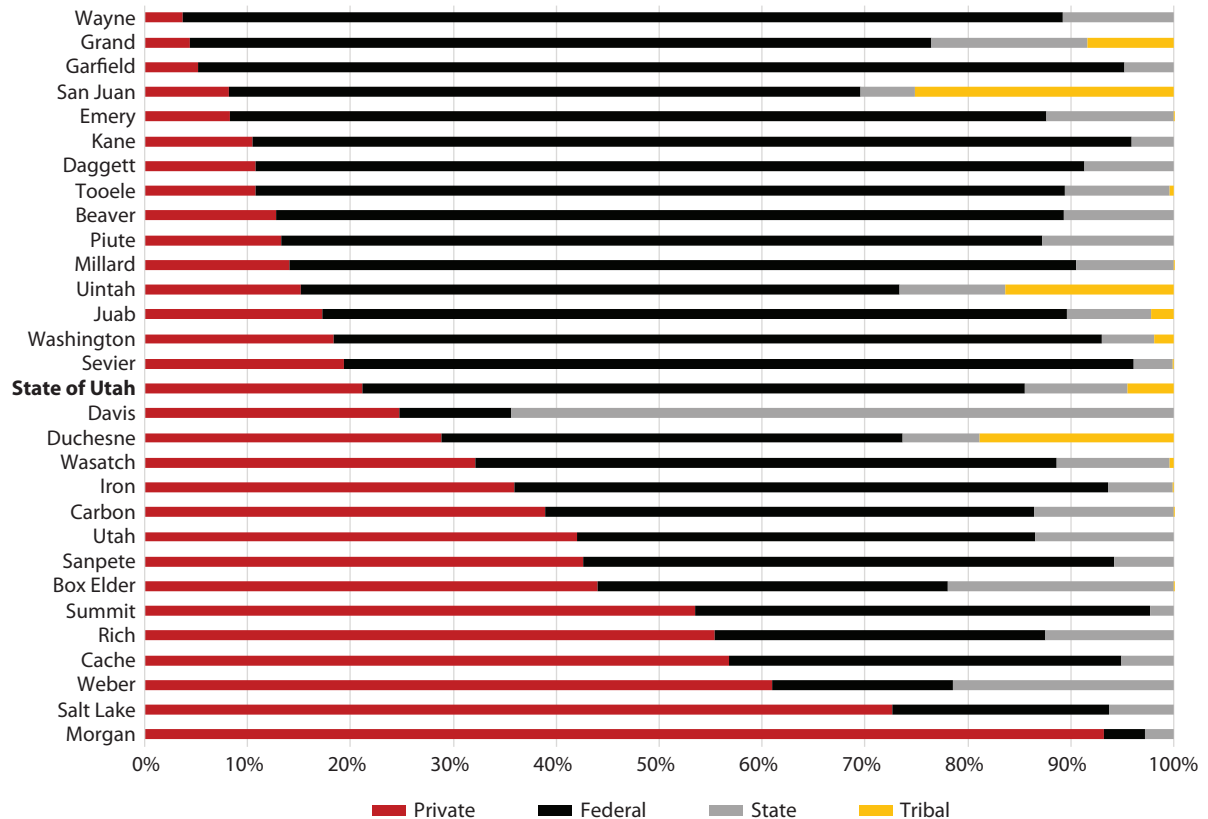
Utah Net Generation Mix, 2000 and 2024

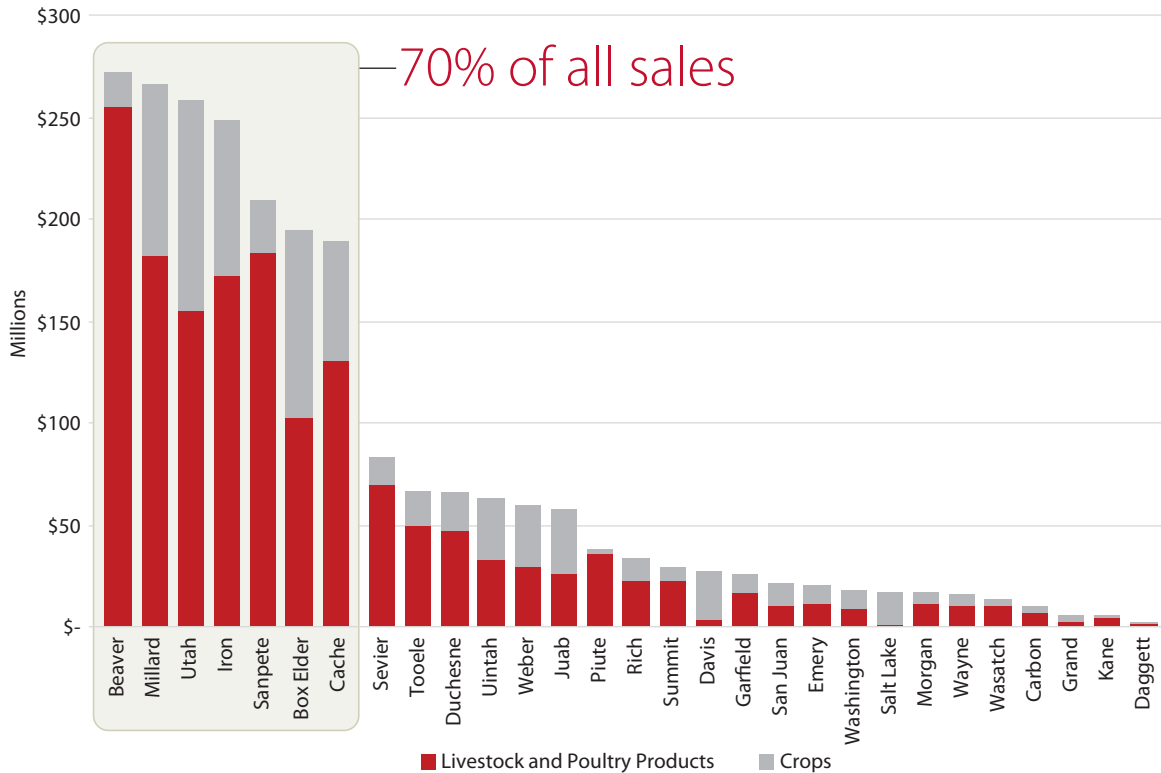
Ranges in County Land Ownership in Utah, 2024

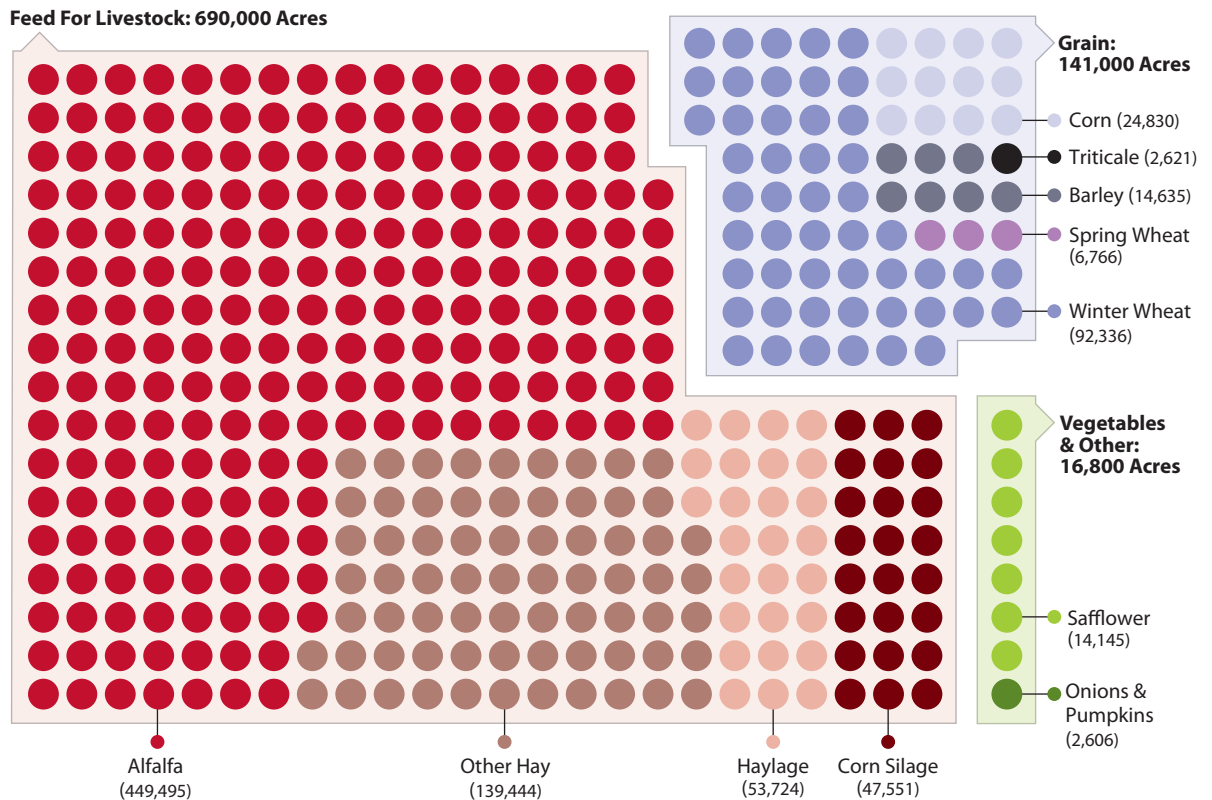
Market Value of Utah Agricultural Products Sold by Type, 2022

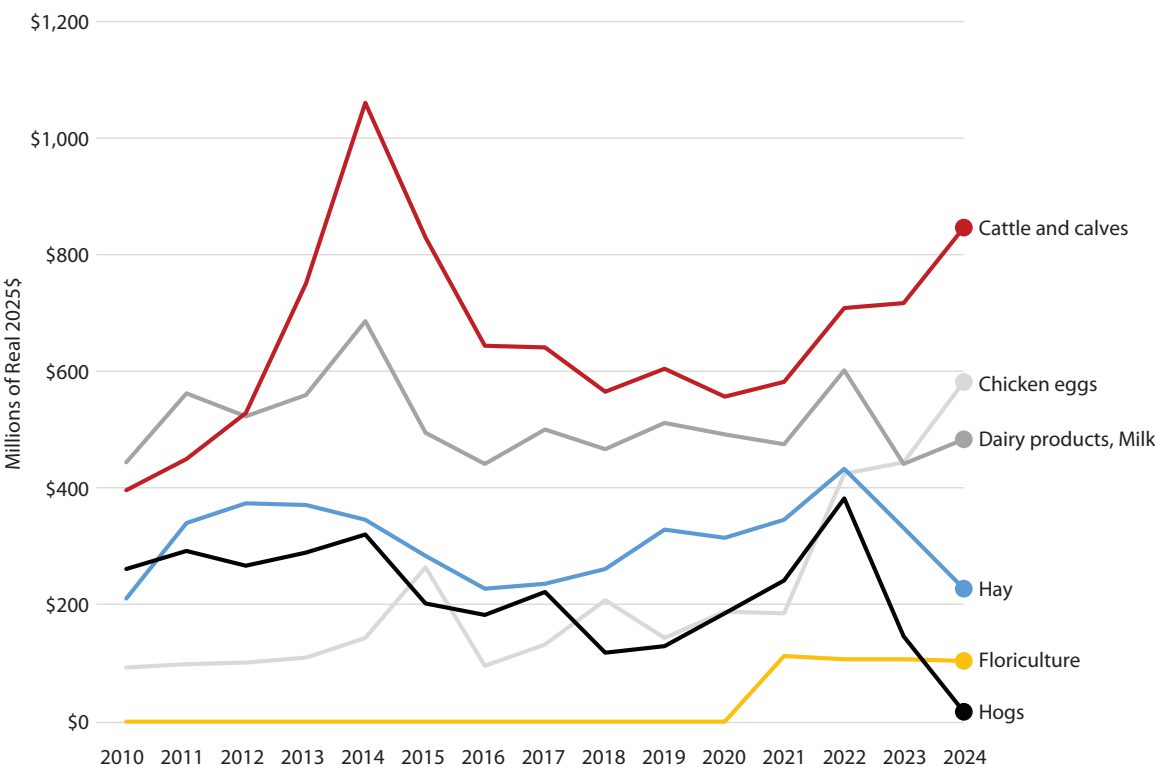
Acres of Harvested Crops in Utah, 2022

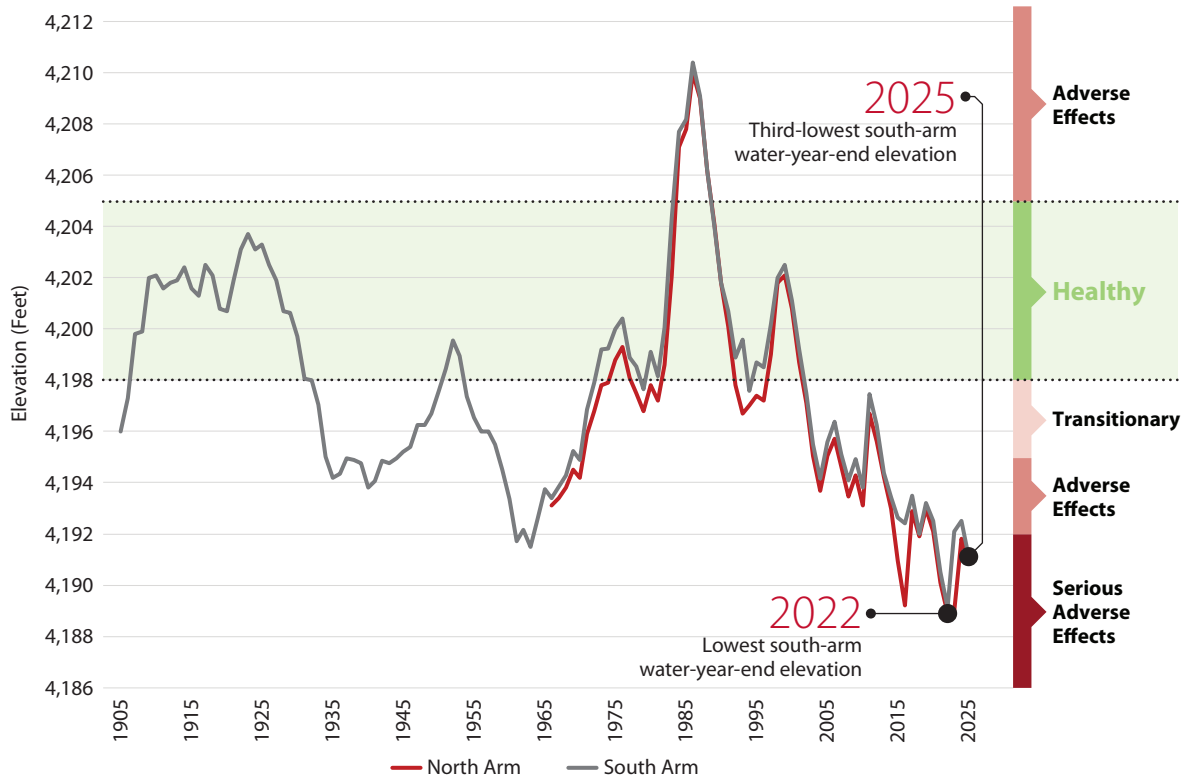
Cash Receipts for Utah's Top Agricultural Commodities, 2010-2024

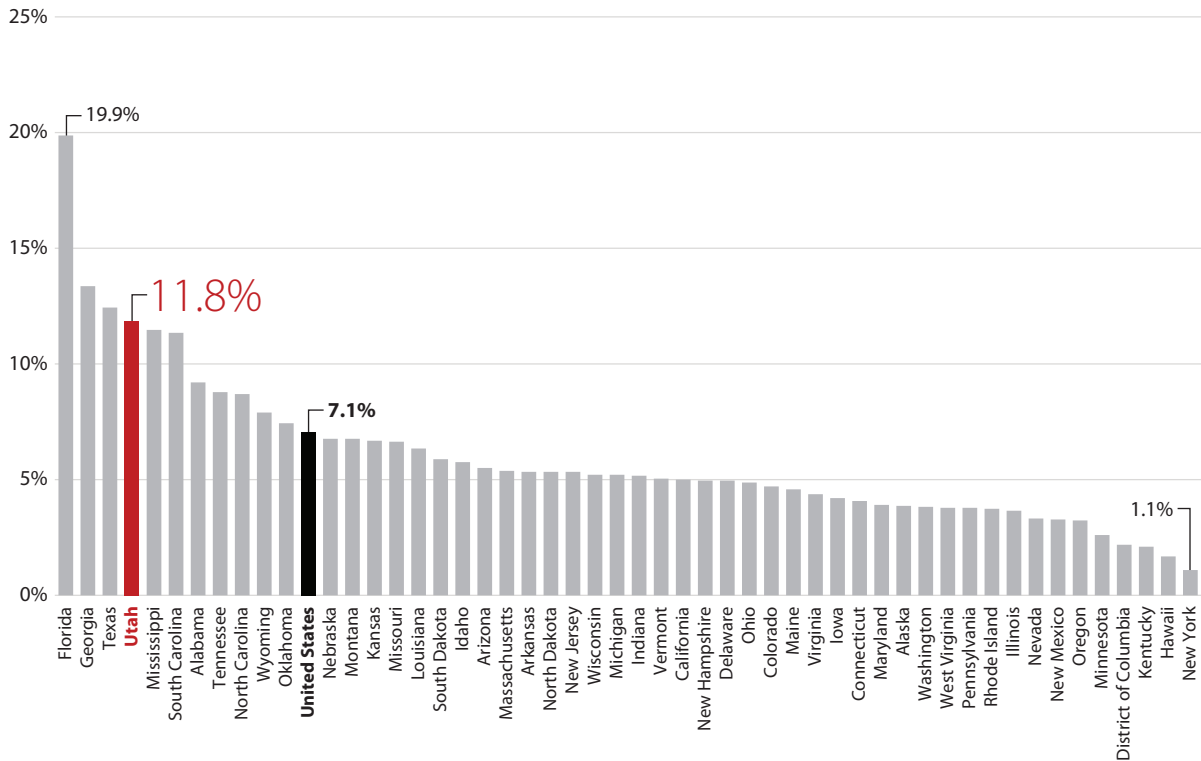
Water-Year-End Elevation of the Great Salt Lake, 1903-2025

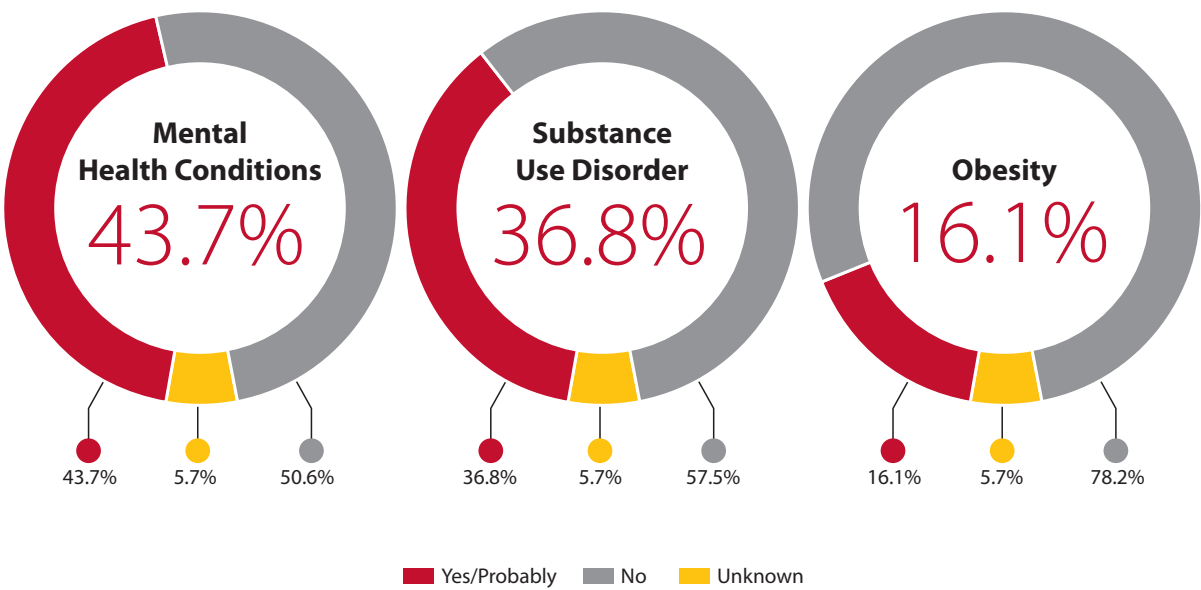

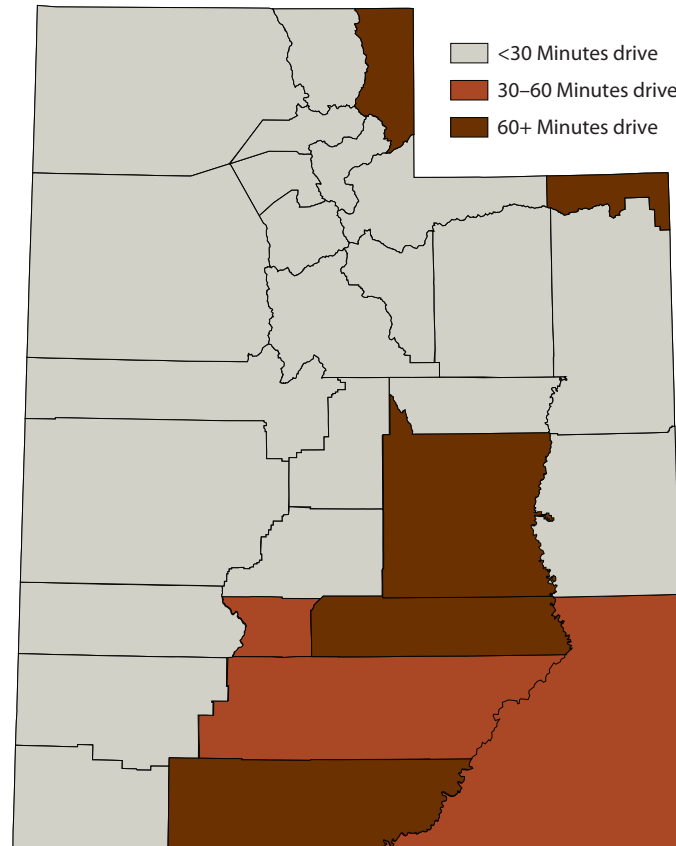
Common Factors Contributing to Maternal Deaths in Utah, 2017–2020

Average Distance in Travel Minutes to the Nearest Utah Birthing Hospital by County, 2022

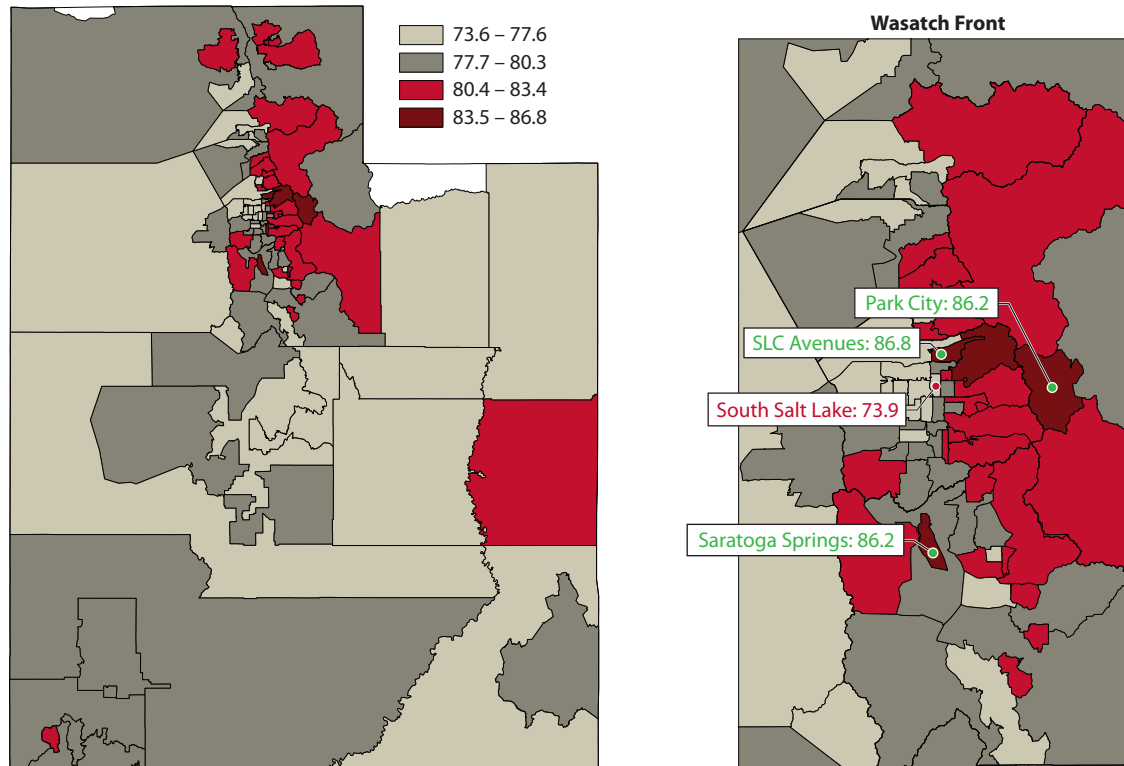

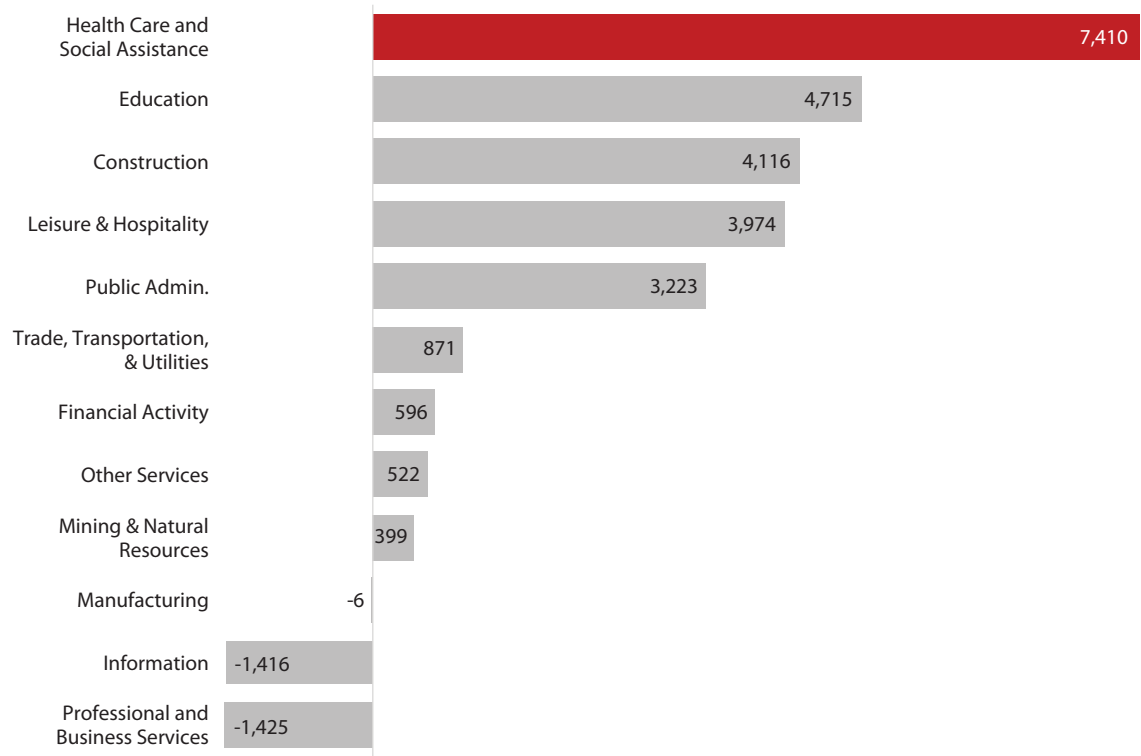
Life Expectancy at Birth by Utah Small Area, 2019-2023

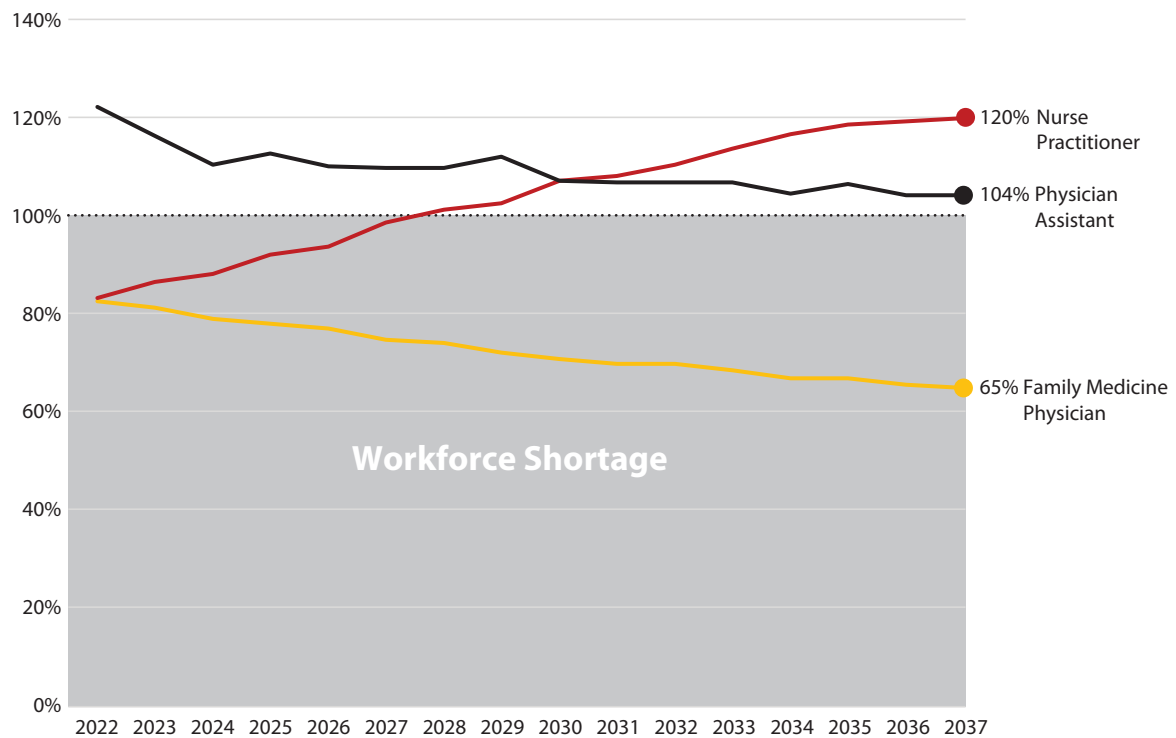
Utah One-Year Employment Growth by Industry, 2023-2024

Utah's Primary Care Workforce Projected Adequacy, 2022–2037

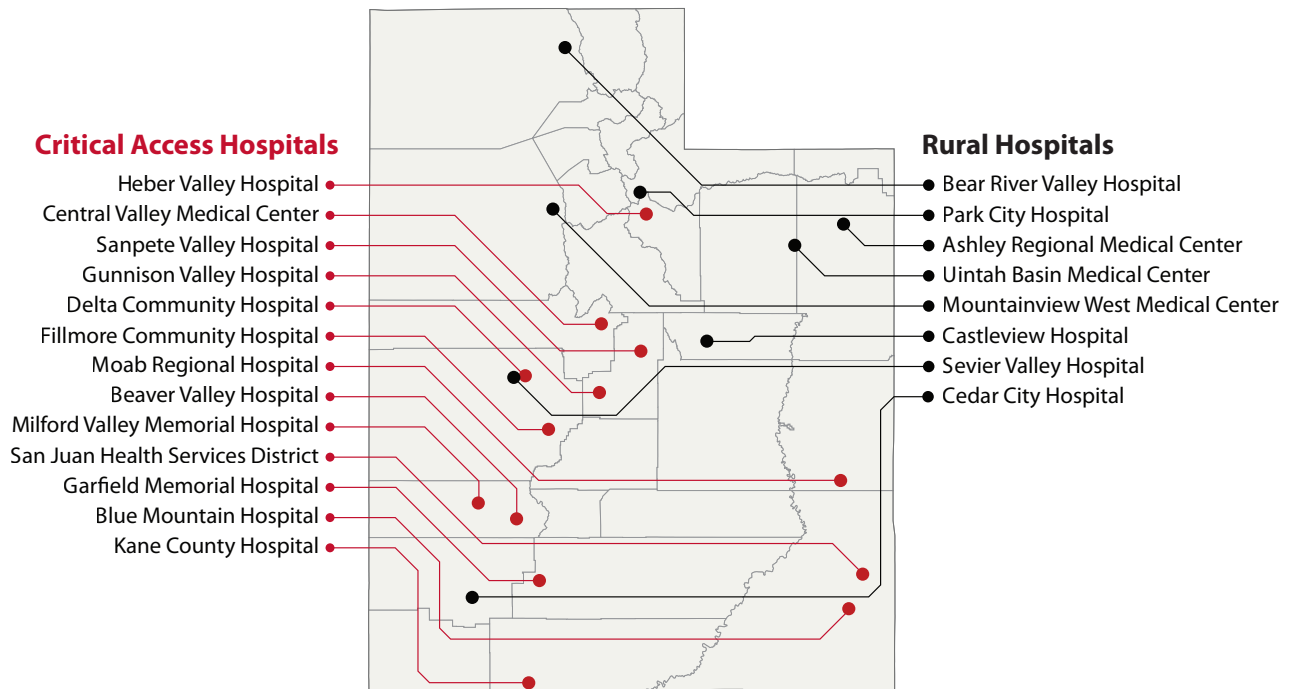

Utah's Rural and Critical Access Hospitals, 2025



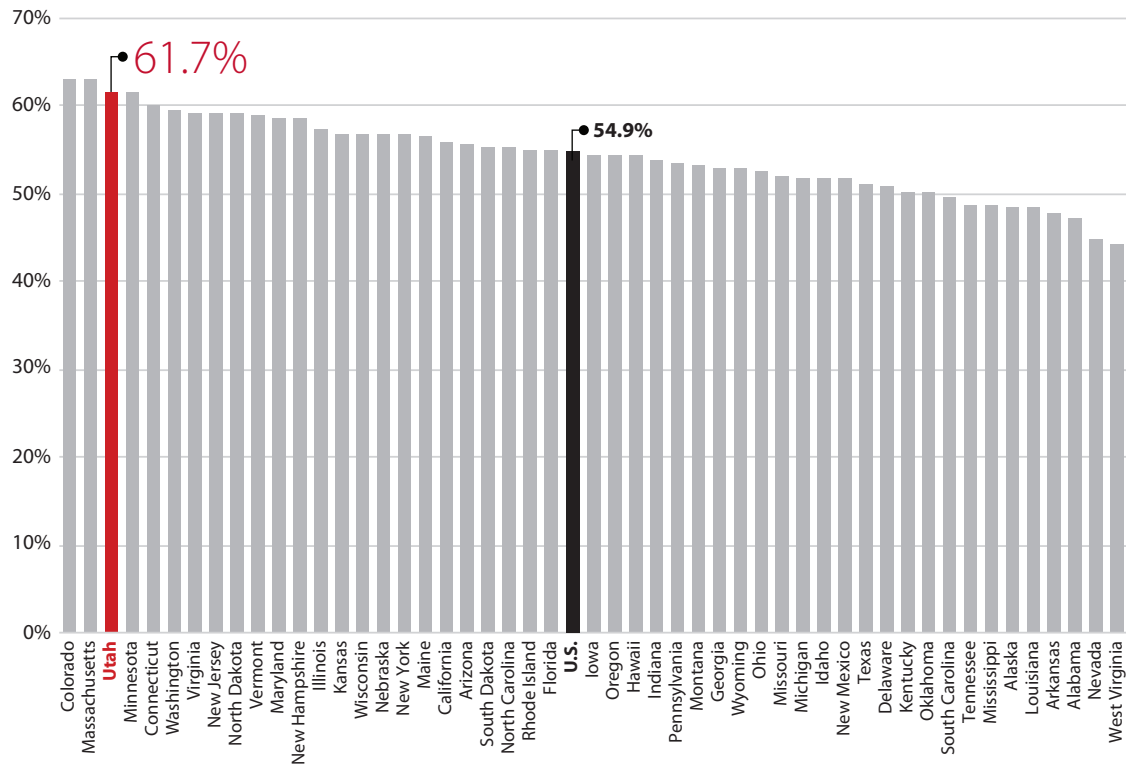

CAHs receive cost-based Medicare reimbursement and operate under more flexible staffing rules to maintain essential medical services in rural communities. Rural hospitals are health care facilities located in non-urban areas, serving communities with limited access to medical services. They typically provide essential emergency, inpatient, and outpatient care, and can face challenges like staffing shortages and financial constraints. Rural hospitals play a critical role in maintaining public health by delivering accessible health care and supporting local economies in rural regions.

Percentage of Population Ages 25-64 with a Postsecondary Certification, Certificate, or Degree

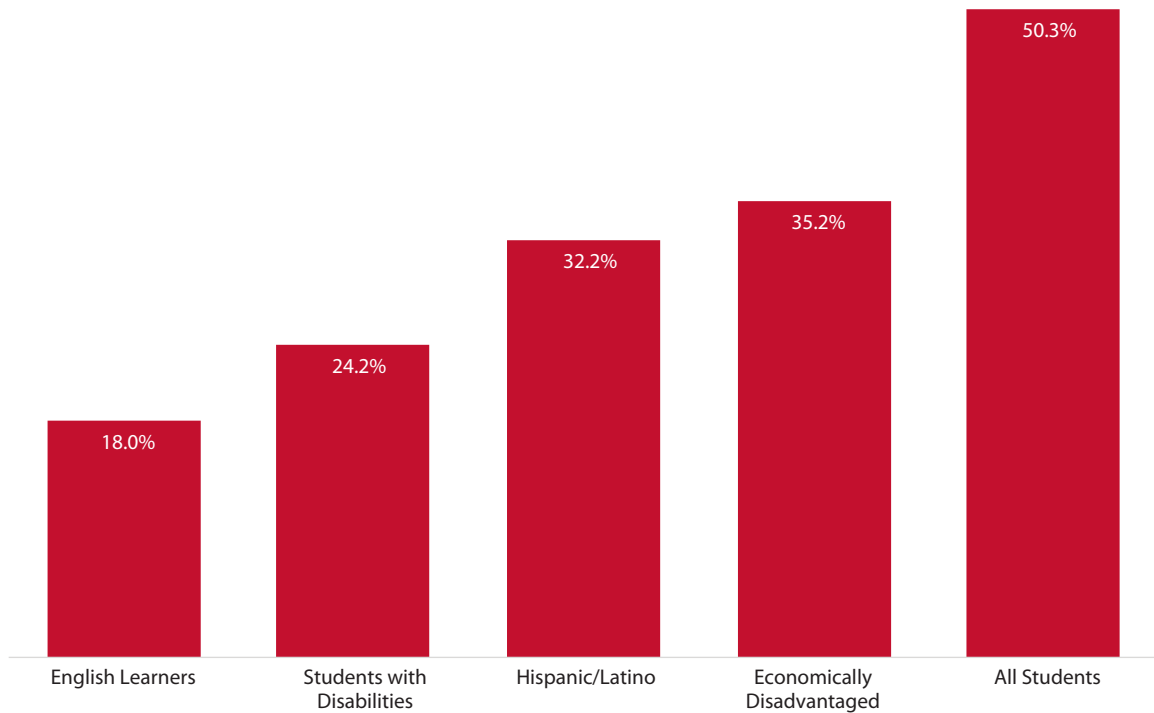

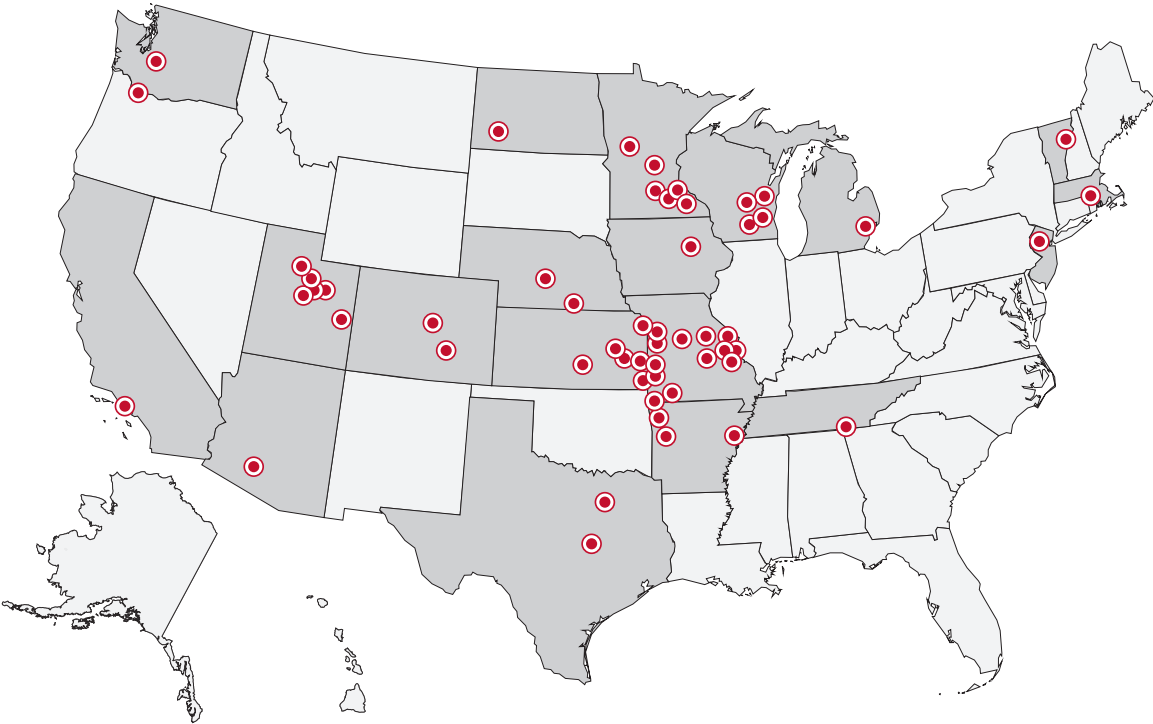
Utah 3rd Grade Reading Proficiency by Student Category, 2025

Center for Advanced Professional Studies (CAPS) Programs by State, 2025

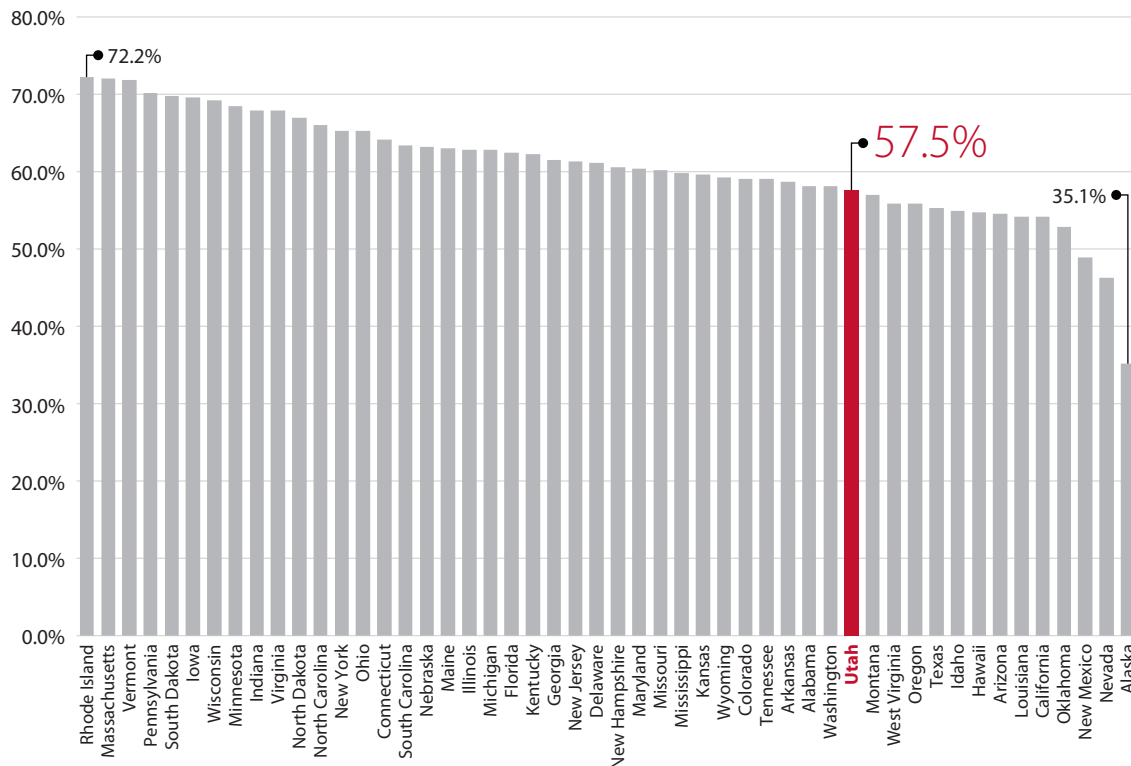

Higher Education Completion Rates by State, 2024

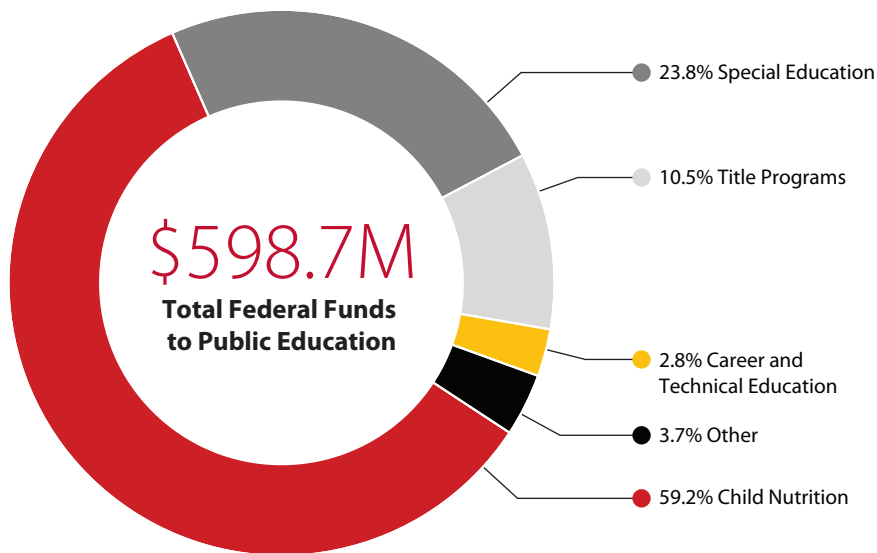
Six-Year Graduation Rates at Degree-Granting Institutions, 2018 Cohort

Federal Funds Appropriated to Utah Public Education by Program, FY2026

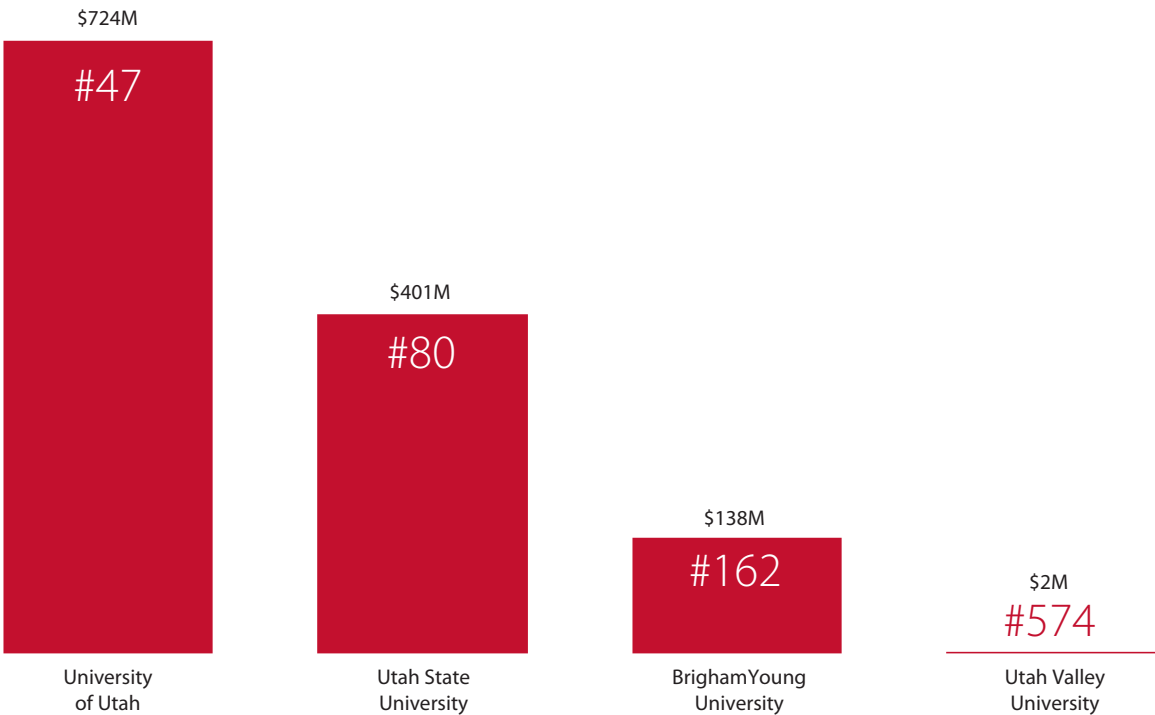

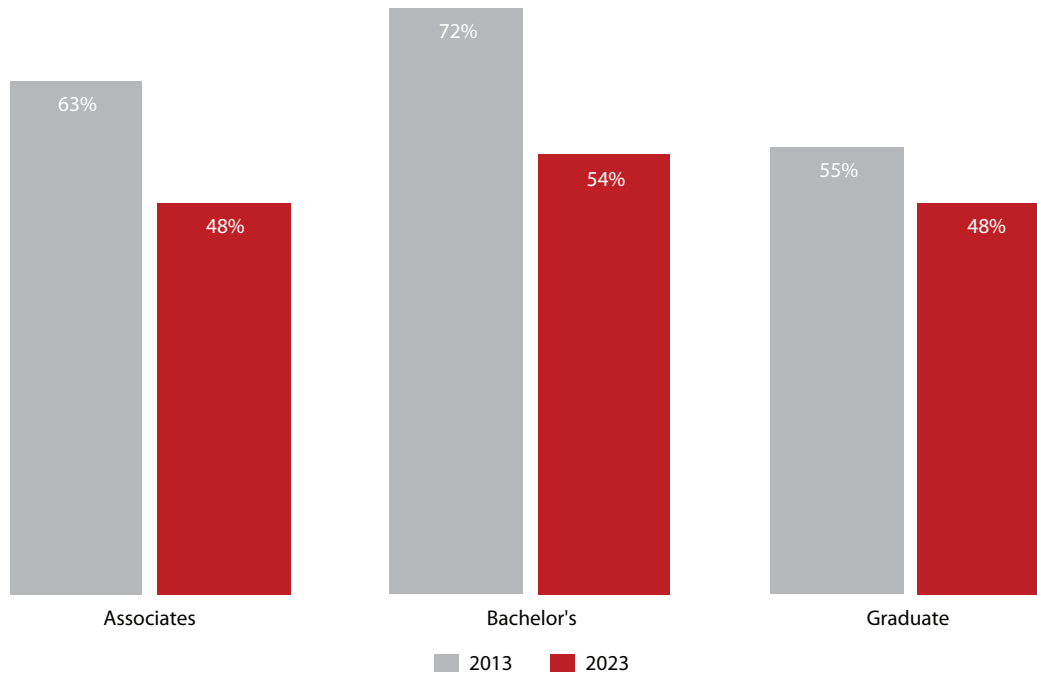
Utah Higher Education Research and Development Expenditures and National Rankings by Institution, FY2023

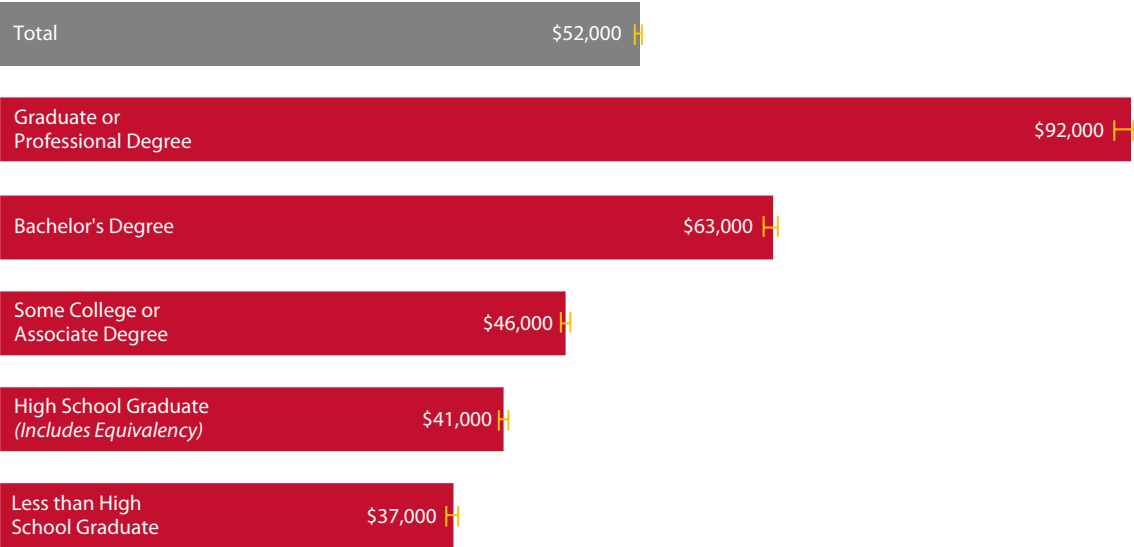
Share of Utahns Who Believe an Associates, Bachelor's, or Graduate Degree is Necessary to Compete in the World Today, 2023

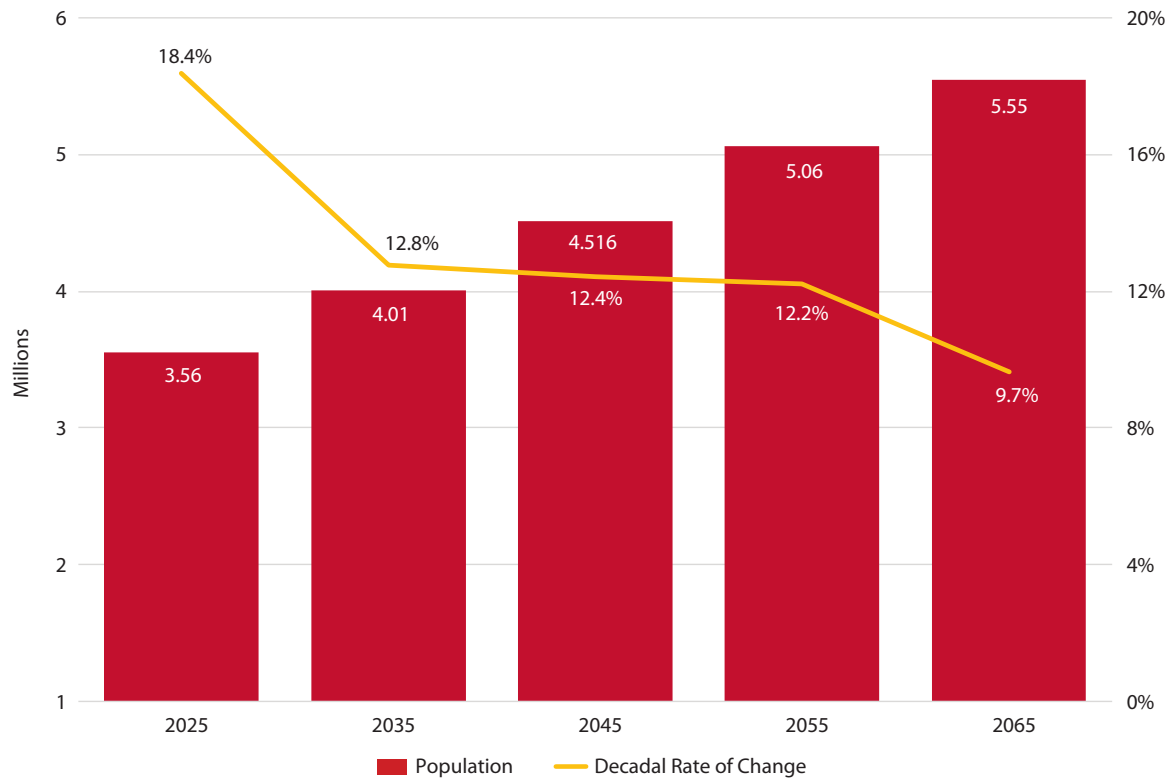
Utah Median Earnings by Educational Attainment, 2023

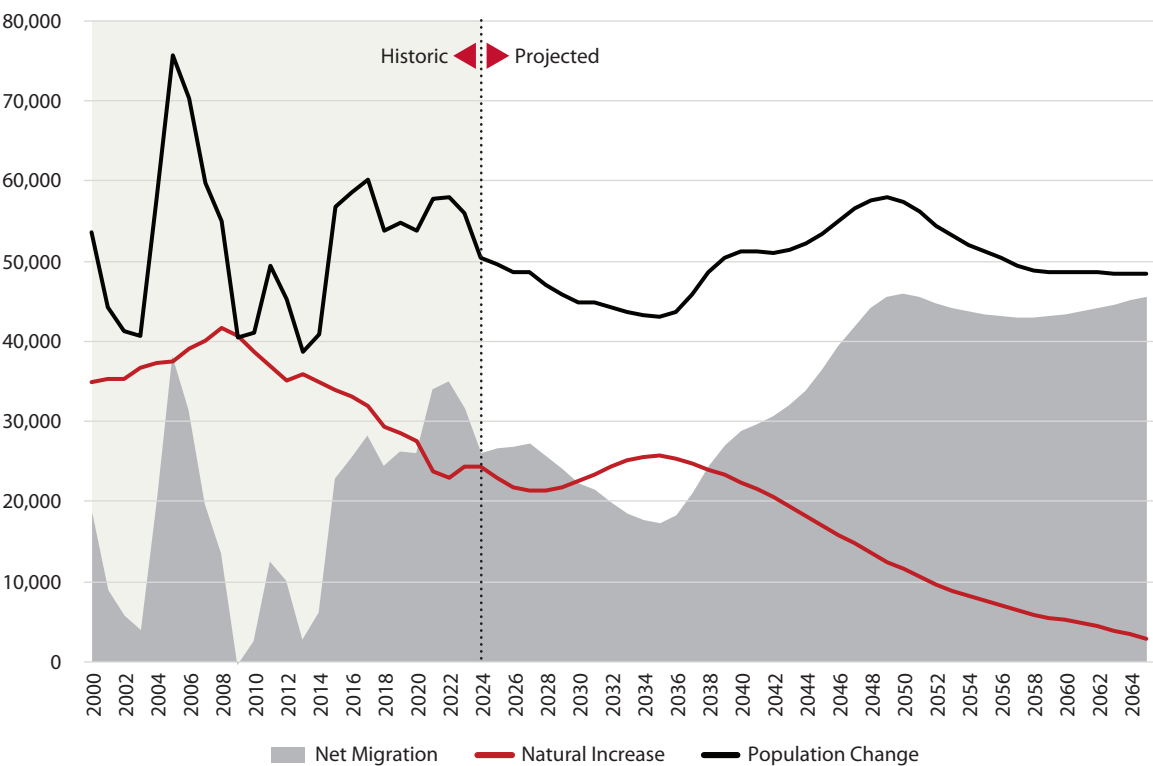
Utah Projected Population Pyramid, 2025 and 2065

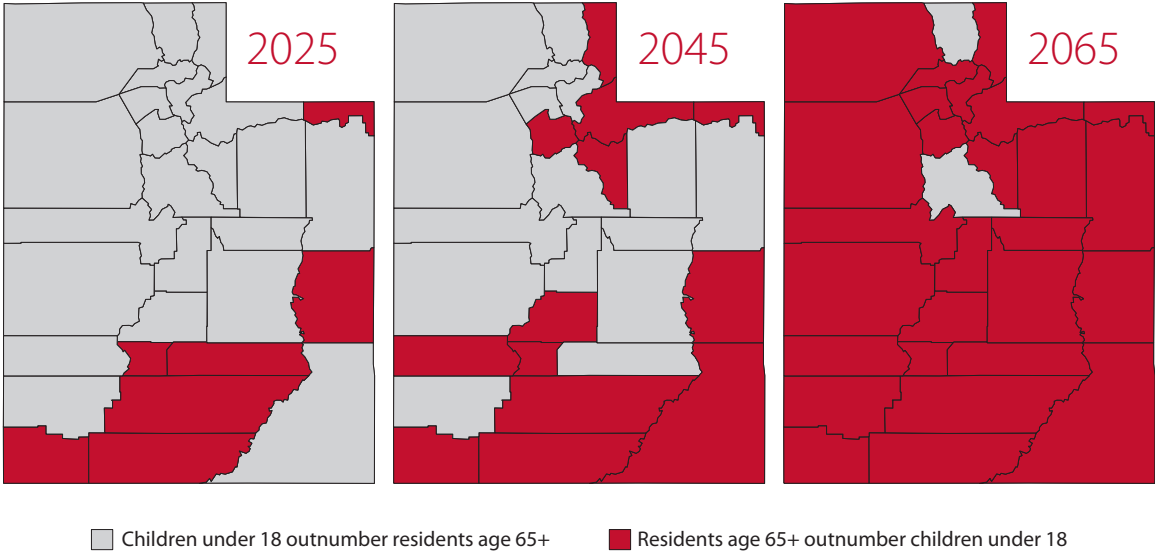
Utah Historic and Projected Population Change and Components of Change, 2000-2065

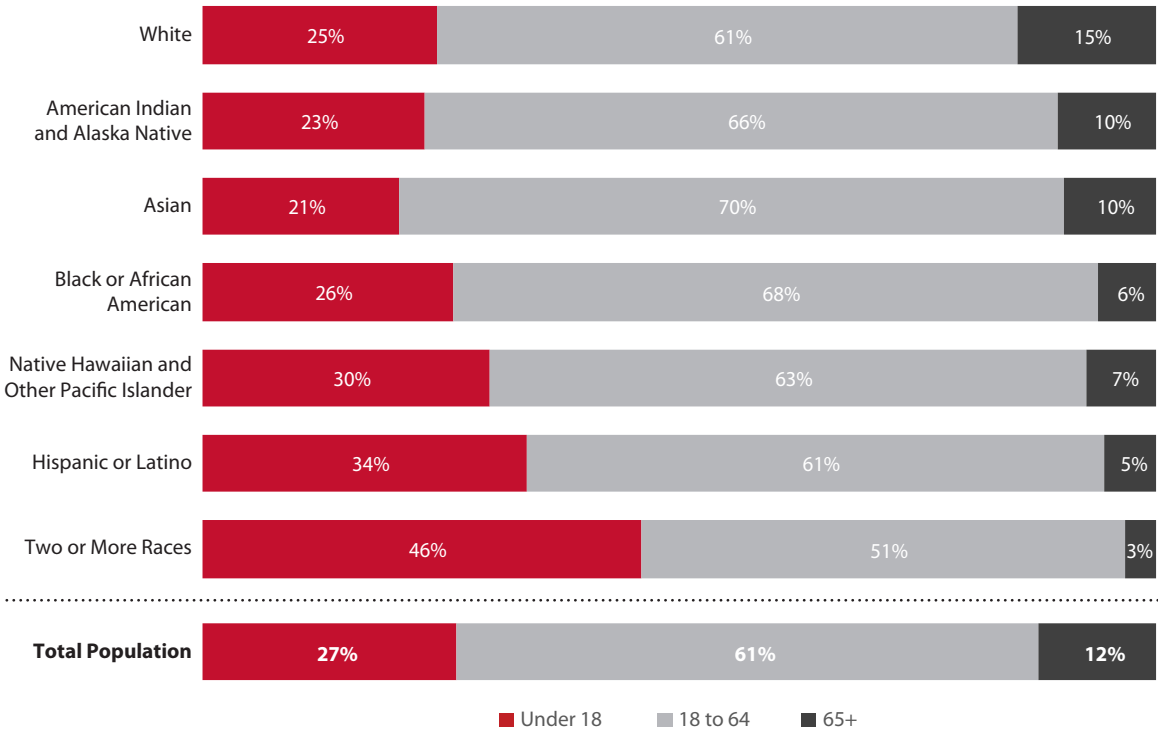
Utah Counties Where Residents Age 65+ Outnumber Residents Under 18, 2025, 2045, 2065

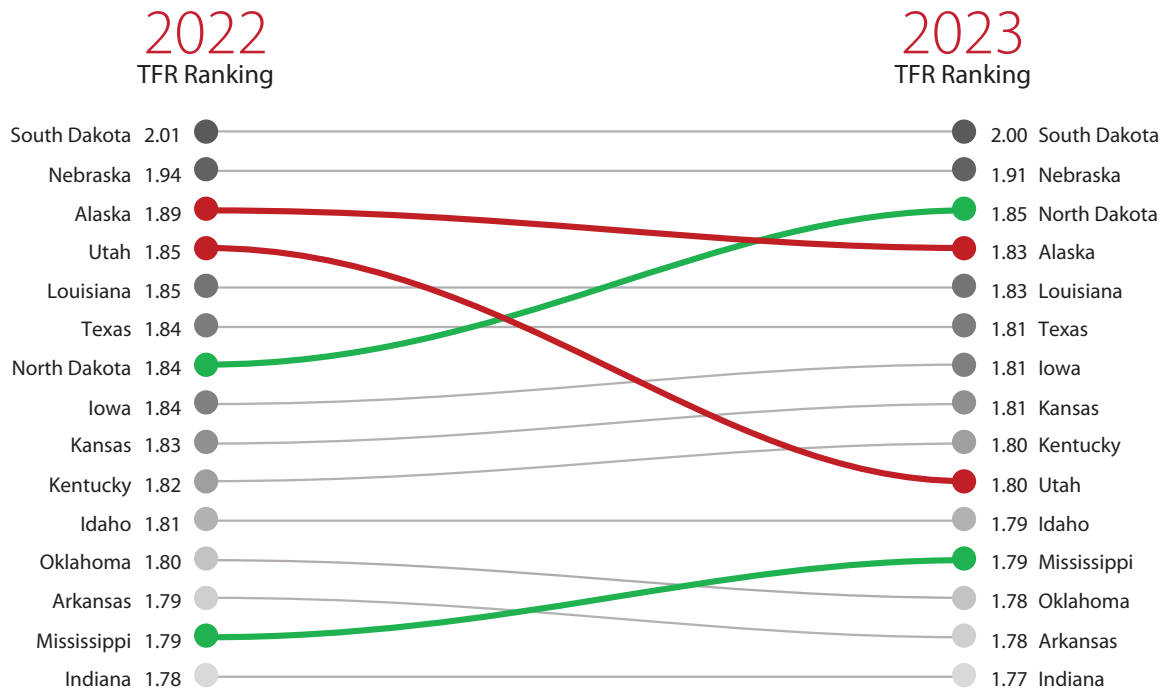
Age Groups in Utah by Race or Ethnicity, 2024

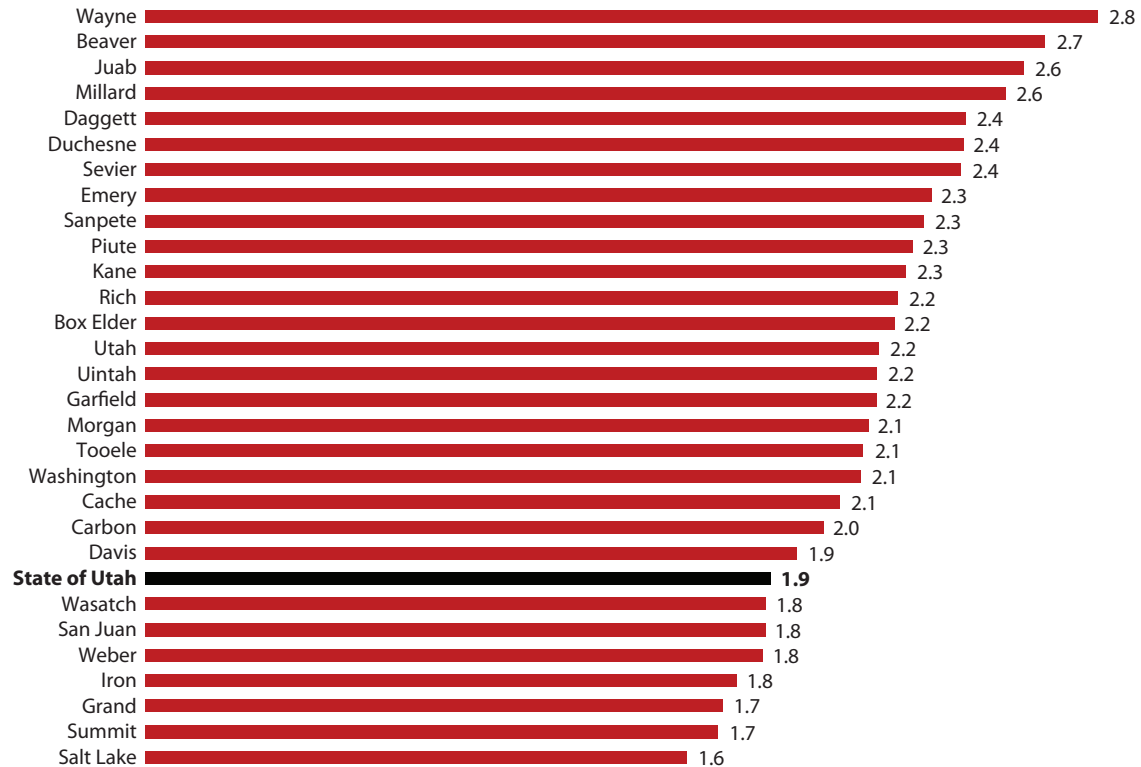
Top 15 States with Highest Total Fertility Rates and their Rankings, 2022 and 2023

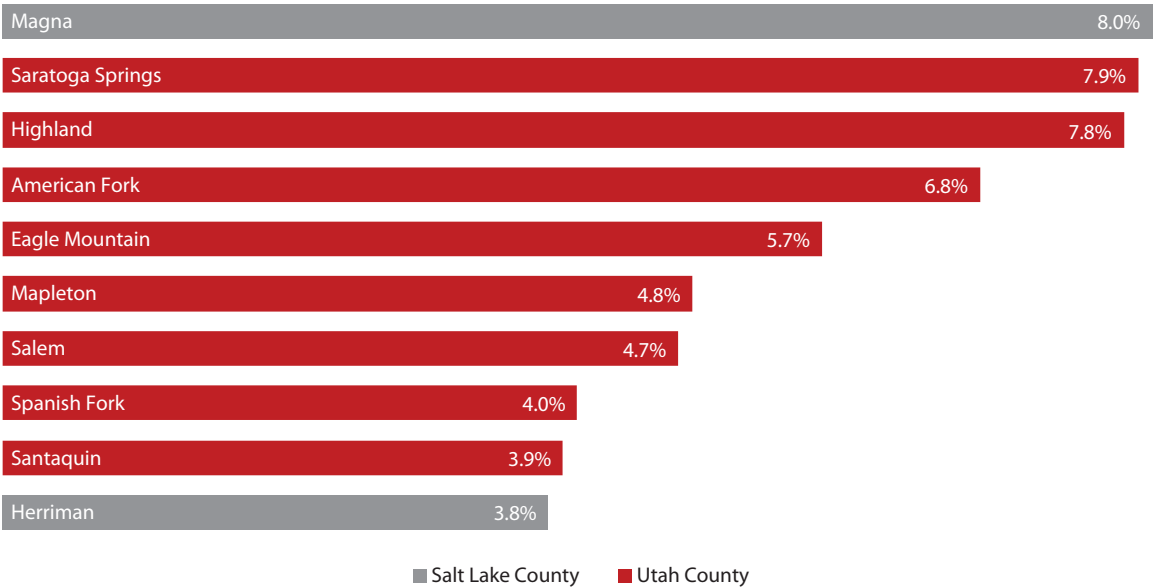
County Total Fertility Rates in Utah, 2023

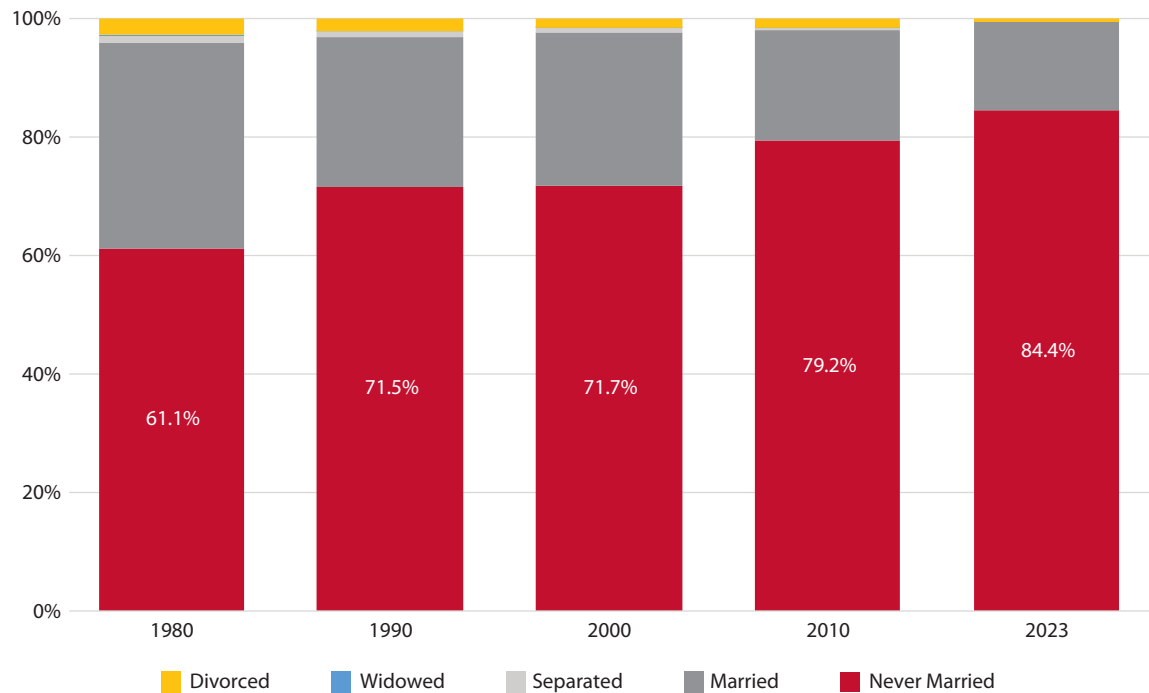
10 Fastest Growing Places in the Wasatch Front, 2023 to 2024

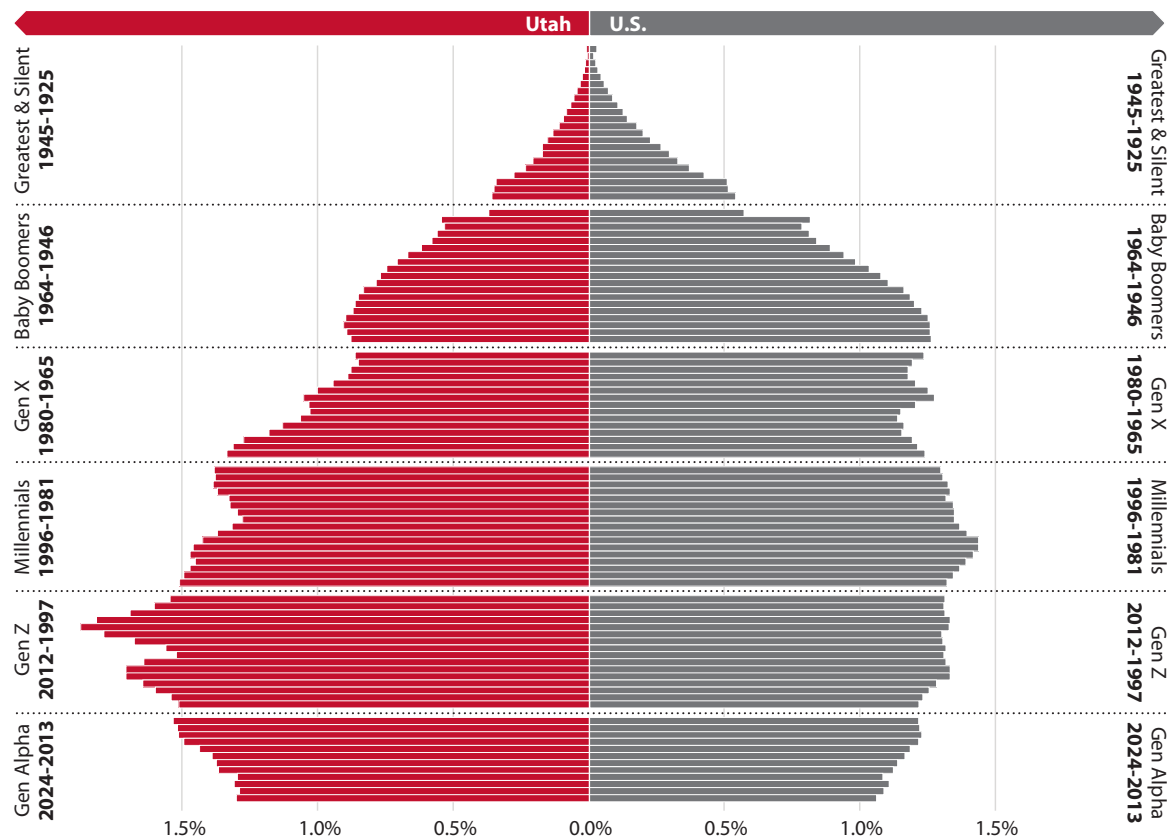
Utah Females Age 15 to 24 by Marital Status, 1980-2023
